### 3B. Project Description

**1. Provide a description that addresses the entire scope of the proposed project.**

Sojourner's Place is a Housing First program and a sub-recipient with DMHAS in the Mental Health Network-Supportive Housing Program (MHN-SHP), a multi-agency collaboration that began in 1995. This program, funded by HUD and led by the CT Mental Health Center (CMHC) is seeking support from the CoC to serve single adults with mental illness and co-occurring substance abuse disorders who are also homeless. The agencies in this partnership provide employment services, day programming, transitional and permanent supportive housing. This is a critical component of the area's services for this population. Sojourner's Place began as a transitional living program in 1995 and converted to PSH in 2010. Identified via aggressive community outreach to soup kitchens, shelters, abandoned buildings and the streets. CHI participates in Coordinated Access housing exit processes using the VISPDAT a vulnerability survey determining entry into housing. Ensuring that the most in need and vulnerable will have housing priority for available units. The program houses 9 women and serves an additional 8 women transitioning from shelter to community based housing. Program data is entered into HMIS, and the case manager enters data at entry, at exit and enters all APR specific data. Among those housed 89% will maintain or increase income and 89% will remain housed or exit into permanent housing.

The VISPDAT a vulnerability survey will determine entry into housing. Ensuring that the most in need and vulnerable will have housing priority for available units. The women will be taken from the centralized Coordinated Access Network (CAN)housing wait-list based upon VISPDAT scores. This system will reduce redundancy for the clients and ensure that all have access to the most appropriate housing available to them.

The clients of Sojourner's Place all have a case manager assigned to them who will help them identify any goals they have and then establish an action plan meant to help guide them toward accomplishment. Case management services include employment, housing search, food, transportation, utility deposits, assessment, creating recovery plans, coordinating overall care, making referrals to behavioral health and medical providers, accessing alternative housing as needed. The case manager will ensure that the client is connected to mainstream services and is enrolled for eligible benefits and entitlements, such as TANF, SSI/SSDI using SOAR, etc. The staff also help women identify and work with natural supports, such as family, volunteer opportunities, faith communities. The sub-recipient provider operating Sojourner's Place collaborates and coordinates with the Department of Labor, and the Bureau of Rehabilitation Services for employment and vocational services.
