3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

The project will provide 8 project-based permanent supportive housing units located in New Haven CT.(2 BR units) for families who are homeless. As existing units turnover, six heads of household will have a diagnosis of HIV/AIDS related illnesses and a mental health and/or substance abuse diagnosis. As units turnover, 100% of beds will be converted to prioritize chronically homeless families; however, if the project is unable to identify a chronically homeless family, a non-chronically homeless family will be served. This objective is consistent with the identified problem of a lack of permanent supportive housing for homeless families in the area. On-site support services will be provided by New Reach (formerly New Haven Home Recovery). Additionally, all participants can receive the following support services from a wide array of community agencies: Assessment of Service Needs, Case Management, Child Care, Education Services, Employment Assistance & Job Training, Food, Housing Search & Counseling Services, Legal Services, Life Skills Training, Mental Health Services, Outpatient Health Services, Outreach Services, Substance Abuse Treatment Services, & Transportation. To identify housing and support service needs, this project participates in the New Haven Coordinated Access System, which identifies the most vulnerable families using a common assessment tool. Housing first principles are utilized to rapidly move families into housing when a unit becomes available. The project will only serve eligible participants, those whose heads of household have a disability and meet HUD's definition of CH and/or homelessness.CoC support is necessary to maintain these projects as full funding is obtained through the CoC Program Competition and the project participates in HMIS, which is supported by the CoC.
