This project administers rental assistance based upon a percentage of participant's income. Therefore, a participant may not use the full funding available per certificate. In order to maximize all available funds, additional units are created when surplus funds are available. The project will continue to manage its budget to continue to house additional people as funding allows and minimize fund recapture.

### 3B. Project Description

**1. Provide a description that addresses the entire scope of the proposed project.**

The project will provide 13 furnished, site-based permanent supportive housing units (efficiency units) at the Cedar Hill apartments. Eligibility for this component includes homeless individuals diagnosed with mental health and co-occurring substance abuse. Individuals may have an HIV/AIDS diagnosis or other disability. As units turnover, 100% of the units (13 total) will be dedicated to chronically homeless. In the event that a chronically homeless individual cannot be identified, a non-chronically homeless individual will be served.

The objectives of this project are consistent with the identified problem of a lack of permanent supportive housing for homeless individuals. This project aims to reduce this number and prevent currently participating individuals from returning to homelessness. Columbus House, Inc. has partnered with the CT Department of Mental Health and Addiction Services to provide onsite case management services, and participants are able to receive additional support services from a wide array of community agencies. These services include, but are not limited to: Assessment of Service Needs, Education Services, Employment Assistance and Job Training, Food, Housing Search and Counseling Services, Legal Services, Life Skills Training, Mental Health Services, Outpatient Health Services, Outreach Services, Substance Abuse Treatment Services, and Transportation.

To identify housing and support service needs, this project participates in the New Haven Coordinated Access Network, which identifies the most vulnerable individuals using the nationally recognized Vulnerability Index Service Prioritization and Service Assistance Tool (VI-SPDAT). The VI-SPDAT serves as the community's common assessment tool, and is used to prioritize those most vulnerable & at risk for housing. New Haven Coordinated Access System protocols are utilized if two participants have the same VI-SPDAT score. Housing first principles are utilized to rapidly move individuals into housing when a unit becomes available. In collaboration with the participant, program staff discuss support needs (on site case management, maintenance with existing or new clinical services, vocation services, etc.) to maintain independent living. The project will only serve eligible participants, those who have a disability and meet HUD's definition of chronic homelessness. The project also participates in HMIS, which is supported by the CoC.
