3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

The Safe Haven Program, opened in 2005, provides 22 permanent housing units (studio apartments) for single, chronically homeless adults with mental illness and/or substance abuse, some of whom will be veterans. This program, located in downtown New Haven, offers residents intensive supportive housing case management and other supports available 24 hours a day. The program is located in an urban area and clients are integrated into the community. Outcome measures include 91% of clients maintaining permanent housing and 91% of clients maintaining or increasing total income. Clients have access to a variety of services, including recovery supports, health and wellness groups, information, referral and employment/vocational counseling. Safe Haven follows the Housing First model and participates in the New Haven Coordinated Access Network. Liberty Community Services engages in targeted outreach to identify persons who are chronically homeless and HIV positive through its Outreach, HIV Testing and Linkages program which is funded through the Department of Public Health. Outreach staff combs neighborhoods where high drug and sex worker activity take place, homeless shelters, soup kitchens, and the public library.

Liberty Community Services collaborated on the design/implementation of the CAN and is an integral member. Our community's C of C is comprised of 17 cities and towns with representatives from HUD and non-HUD funded organizations and other stake holders. Referrals for openings in the 22 units flow through the CAN.

In response to a community need a Homeless Day Program was started which offers food, facilities, supports and a safe place during the day for up to 25 individuals. The Day Program is an outreach effort intended to engage homeless individuals into services that help them to gain housing, medical treatment, employment and entitlements. Safe Haven collaborates with the Community Health Care Van, South Central Rehabilitation Services, Multicultural Ambulatory Addiction Services, Emergency Shelters and Home Health Care Agencies. The program participates in HMIS.

Safe Haven offers the following services: assessment of service needs, case management, employment assistance, food, housing search and counseling services, life skills training, transportation, mental health services and outreach services.
