The CT0023 Hartford Mary Seymour Place renewal project had some funds recaptured by HUD during the most recent expired grant term. The recaptured funds were due to the tenants having income and thus paying a higher tenant portion of the rent, as well as more than usual departures from the program, including one tenant death. The Greater Hartford Coordinated Access Network (Coordinated Entry) process has been slower than anticipated in finding CH people interested in this project-based option when scattered site options are available. Property management has been slower than previously to prepare turnover units for re-occupancy. We will continue to monitor expenditures for this grant.

### 3B. Project Description

**1. Provide a description that addresses the entire scope of the proposed project.**

Mary Seymour Place Apartments provides permanent supportive housing rental assistance and case management services to fifteen (15) individuals, who meet the HUD definition of homelessness and are disabled due to severe mental illness, co-occurring disorders, or HIV/AIDS. This project follows HUD Notice CPD-14-012 to prioritize serving CH persons w/the longest history of homelessness & most severe service needs in the order indicated in the notice. The Greater Hartford Coordinated Access Network (GH CAN) coordinates outreach to unsheltered and sheltered people, and determines priority based on length of homelessness and vulnerability, using a common assessment tool. GH CAN coordinates Outreach teams who find and navigate for the most vulnerable chronically homeless individuals outside and in shelters. The project will rely on HUD funds to support activities that cannot be funded through mainstream sources; HUD CoC funds are needed to make this project possible, work to end chronic homelessness in CT BOS CoC. There is a critical community need for PSH to serve CH persons in the region. Case management is provided on-site, and support services are available near the building's location in the North End of the City of Hartford, Connecticut. Housing is provided in single-site apartments located within easy access to public transportation, grocery shopping, churches, schools, and other community resources. This project would not be able to continue without Continuum of Care funding. My Sisters' Place staff works in partnership with tenants to develop an Individual Recovery Plan. Participants choose self-identified service planning goals, including: accessing physical and mental health care; obtaining job skills training and education needed for employment; and finding employment. Case managers provide support for individuals to apply for Federal and State entitlement benefits, SOAR; provide connection to employment training resources, jobs training/employment or educational programs; provides linkage to substance abuse treatment, healthcare providers, mainstream community resources; greater connectivity to natural supports; and to counseling. The project will continue to participate in HMIS. The applicant and partners participate in the GH CAN and CoC. The Project addresses the need in the community for safe, decent, affordable housing; and provides the support services needed for individuals' recovery and increased self-sufficiency. This project follows Housing First, provides housing quickly w/o barriers such as income, sobriety, or service participation requirements. The GHRA program's experienced housing coordinators inspect apartments, confirm leases & generate proper tenant rent portion calculations. Performance measures have the goals of 93% of participants remaining in or moving to permanent supportive housing; and 87% of adults of 18 years old and older retaining or increasing income during the project year or at exit of the program.
