

### **3B. Project Description**

**1. Provide a description that addresses the entire scope of the proposed project.**

YWCA Hartford Region is requesting of HUD funding for its Soromundi Commons Supportive Housing Program (SCSHP). Without CoC funding, YWCA could not continue to operate this high-priority housing program.

The 29 units in this project are part of YWCA’s housing program offered at Soromundi Commons, which provides comprehensive services in a fully integrated setting. Located at 135 Broad Street in Hartford, this supportive housing facility includes an emergency shelter, and permanent efficiencies and one-bedroom units.

YWCA is an active participant in the Hartford Continuum of Care (CoC) and operates according to the Housing First model, carried out through the Greater Hartford Coordinated Access Network (GH CAN). Through GH CAN, homeless individuals fill out a universal housing application, and complete a Vulnerability Index (VI-SPDAT). Chronically homeless individuals are given priority in referral housing. As part of Coordinated Access, partner staff conducts outreach on the street and other locations not meant for human habitation, outreach to local shelters and service agencies. YWCA participates in HMIS. This project provides support services to individuals struggling with mental illness and/or chronic substance abuse, and who have incomes at or below 50 percent of state median income.

Staff provides critical support to help participants remain housed and increase stability. YWCA operates under the principle of low barrier to entry. The most important project component is personalized care, contracted through Chrysalis Center, which supports clients in meeting three overarching goals: residential stability, increasing job-readiness and/or income, and a greater level of self-sufficiency. These goals are aligned with HUD Standard Performance Measures for PH programs. In the program operating year or at program exit, we expect 1) at least 91% of clients will remain in permanent housing and 2) 82% maintain or increase their total income.

Additional supportive services offered onsite include outpatient medical services provided by Charter Oak Health Center. Participants also receive monthly groceries from Foodshare, and bus passes are available as needed. Chrysalis Center also provides life skills training and employment services through its Recovery and Empowerment Center. Case managers refer participants to education and legal services on an as-needed basis. Staff contracted through Konover Residential Corp. provide 24/7 residential assistance. This comprehensive spectrum of services improves the quality of life for chronically homeless individuals while increasing their chances for re-engagement within the community.
