3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

This project will provide 12 Sponsor-based Rental Assistance supportive housing certificates. We are serving 8 HOH chronically homeless individual and/or families. Of the 8 households 5 are individuals and 3 are families (the chronic family units have 5 minor children). For a total of 13 chronically homeless people being served. As units turn over they will be dedicated to serving chronically homeless and our most at risk individuals and/or families. Eligibility for this program include chronically homeless individuals and/or family's diagnosed with mental health and/or co-occurring substance abuse. The Point In Time count demonstrated a significant need in the Middletown area. The projects goal is to decrease chronic homelessness, prevent program participants from returning to homelessness and to promote community integration. To identify housing and support service needs, this project participates in the Middletown, Meriden, Wallingford Coordinated Access System, which identifies the most vulnerable individuals and families using the Vulnerability Index Service Prioritization and Decision Assistance Tool (VI-SPDAT). Applicants are prioritized for housing based on their identified risk. Our (HAPS) Housing assessment, prioritization, and selection committee which is comprised of local housing and shelter providers meets bi-weekly to facilitate the coordinated exit initiative and house our most vulnerable and chronically homeless people. Applicants either are coming from homeless shelters or the streets. Housing first principles are utilized to rapidly move families into housing when a unit becomes available. 90% of the participants are expected to remain in or exit to permanent housing during the operating year and 90% are expected to increase or maintain their total income. 
