During this grant period several tenants increased their income and/or obtained income which decreased the housing assistance payments. The project was able to create certificates to help minimize the recapture of funds and house more homeless families.

3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

This project funds 20 scattered site tenant based certificates for homeless individuals and/or families throughout the Middletown/Middlesex area. Of the 20 TRA certificates there are 3 efficiencies, 8-1 bedroom, 6-2bedroom, and 3-3bedroom. Individuals and families diagnosed with serious mental illness and/or chronic substance abuse are eligible. While this project's request for funding will remain unchanged this program will prioritize chronically homeless (CH) status when filling vacancies. We are currently serving 9 chronically homeless families and/or individuals and any turnover will be replaced with chronically homeless families and/or individuals. To identify housing and support service needs, this project participates in the Middletown, Meriden, Wallingford Coordinated Access Network, which identifies the most vulnerable individuals and families using the VI-SPDAT. Applicants are prioritized for housing based on their identified risk and feedback from all of our local community providers. Applicants either are coming from homeless shelters or the streets. Our Housing Assessment Prioritization and Selection (HAPS) committee meets bi-weekly to assess and prioritize our homeless population. Housing first principles are utilized to rapidly move families into housing when a unit becomes available. The project aims to reduce homeless individuals in the community and prevent current participants from returning to homelessness. The Point In Time (PIT) count indicated a significant need in our area. During the PIT Count this project was at full capacity. CoC support is necessary to maintain these projects as full funding is obtained through the CoC Program Competition. Housing is located in areas which are easily accessible by public transportation and accesses mainstream resources such as shopping centers, schools, and places of worship. Community Health Center and River Valley Services work with our participants to provide case management services. Case Managers provide services in the participant's homes, community and office and assist individuals with accessing resources to employment, benefits and health care services to ensure successful permanent supportive housing. Case management also provides the linkage to support services including but not limited to health care, job training, employment, education, behavioral health and advocacy. 90% of participants are expected to remain in permanent supportive housing or exit to permanent housing during the operating year and 90% of participants will increase or maintain their household income. This program follows a Housing First model and utilizes HMIS.
