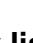

### 3B. Project Description

**1. Provide a description that addresses the entire scope of the proposed project.**

In CT, there are 3 very low-income households for every available housing slot and vacancy rates are 31% lower than the national average. There is a 3-6 year wait for subsidized housing. According to the 2017 CT Point-in-Time (PIT)Count, there were 634 persons on the night of the PIT experiencing homelessness just in the city of Hartford -- the highest number in the State. Of these, 486 were single adults, 57 of whom were chronically homeless. Few families in the state are chronically homeless, on the night of the PIT, there were 55 adults in families and 92 children in families in the city. In addition, 40 of the 634 total were unsheltered. in this region. CRT PSH Consolidated will combines services for 45 chronically homeless households (primarily singles) and 12 family households (with at least one adult and one child). The family households include an adult with a disability and preference is given to the chronically homeless. All single households will be chronically homeless and typically have mental health, substance abuse or co-occurring disorders. A relatively high percentage will have three or more disabling conditions. This program also serves people with HIV/AIDS, victims of domestic violence, and veterans. Units range from a few efficiencies to three-bedroom apartments. While the majority are located in East Hartford, clients could be situated throughout Hartford County. This program adheres to the Housing First model and regulations. While all services (outside of housing) are voluntary, it is expected that all will receive intensive case management and most will be linked to a variety of internal and external support services. These may include behavioral health, child care, employment, housing counseling, life skills, education (for children and adults), financial literacy, food pantries, food, etc. CRT is able to provide many of these services in-house but the agency also has strong links with such organizations as Goodwin College, Intercommunity (for behavioral health), Interval House (CT's leading domestic violence provider), Capital Work Force, Charter Oak Health Center, among Community Health Services among others. Outcomes measures will include 91% of persons will remain in permanent housing or exit to permanent housing as of the end of the operating year and 91% of heads of households will have maintained or increased their total income with the caveat the young adults (18-24) can skew the income number as we hope to place them in training or educational programs that decrease the hours that they can work. This program has excellent retention of clients. New households will be identified and referred by the Greater Hartford CAN. 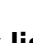

In CT, there are 3 very low-income households for every available housing slot and vacancy rates are 31% lower than the national average. There is a 3-6 year wait for subsidized housing. According to the 2017 CT Point-in-Time (PIT)Count, there were 634 persons on the night of the PIT experiencing homelessness just in the city of Hartford -- the highest number in the State. Of these, 486 were single adults, 57 of whom were chronically homeless. Few families in the state are chronically homeless, on the night of the PIT, there were 55 adults in families and 92 children in families in the city. In addition, 40 of the 634 total were unsheltered. in this region. BOS Consolidated PSH combines services for 28 chronically homeless households (primarily singles) and 12 family households (with at least one adult and one child). The family households include an adult with a disability and preference is given to the chronically homeless. All single households will be chronically homeless and typically have mental health, substance abuse or co-occurring disorders. A relatively high percentage will have three or more disabling conditions. This program also serves people with HIV/AIDS, victims of domestic violence, and veterans. Units range from a few efficiencies to three-bedroom apartments. While the majority are located in East Hartford, clients could be situated throughout Hartford County. This program adheres to the Housing First model and regulations. While all services (outside of housing) are voluntary, it is expected that all will receive intensive case management and most will be linked to a variety of internal and external support services. These may include behavioral health, child care, employment, housing counseling, life skills, education (for children and adults), financial literacy, food pantries, food, etc. CRT is able to provide many of these services in-house but the agency also has strong links with such organizations as Goodwin College, Intercommunity (for behavioral health), Interval House (CT's leading domestic violence provider), Capital Work Force, Charter Oak Health Center, among Community Health Services among others. Outcomes measures will include 91% of persons will remain in permanent housing or exit to permanent housing as of the end of the operating year and 91% of heads of household will have maintained or increased their total income with the caveat the young adults (18-24) can skew the income number as we hope to place them in training or educational programs that decrease the hours that they can work. This program has excellent retention of clients. New households will be identified and referred by the Greater Hartford CAN. The program uses HMIS and it could not function or continue to house participants without CoC funding.

### 3B. Project Description

**1. Provide a description that addresses the entire scope of the proposed project.**

In CT, there are 3 very low-income households for every available housing slot and vacancy rates are 31% lower than the national average. According to the 2017 CT Point-in-Time (PIT) Count, there were 633 persons staying in emergency or transitional housing in the city of Hartford. Of these, 486 were single adults of whom 57 were chronically homeless. Through Project Teach Permanent, 17 scattered-site, 1-bedroom apartments will house chronically homeless and disabled households (age 18 and over) with no employment requirement for housing. This program also adheres to all other Housing First requirements. The Greater Hartford Coordinated Access Network (GH-CAN) prioritizes individuals with longest term homelessness, vulnerability and high VI-SPDAT scores for inclusion in the permanent supportive housing programs as these are the people who are most in need of longer term services and most at-risk of premature death if they are not housed. Clients will be recruited through the GH CAN, which provides a shared, prioritized way of identifying those very vulnerable clients best suited for PSH. This program cannot function or continue housing participants without CoC funding. Support services are particularly essential for these individuals. Among other things, our Housing First model ensures that chronically homeless individuals are eligible for clients regardless of substance use and/or agreement to participate in treatment. Project TEACH Permanent only receives leasing and operating dollars from HUD. Support services are funded through separate sources. Although services are not mandatory, this program has an excellent track record at helping its clients access and attend programs that help them to deal with their behavioral health issues (most clients have co-occurring disorder), gain financial literacy, learn vocational or employment skills, get appropriate health services, etc. CRT closely coordinates services with our CoC partners and other providers in the community. The agency is fortunate to have many mainstream services available in-house but the program also partners with such organizations as Goodwin College, Chrysalis, South Park Inn, Food Share, FQHCs and others so that clients needing and wanting additional supports can receive them.

Apartments are leased one-bedrooms. Accessibility to resources in the community is a key factor in as clients choose scattered-site apartment locations. As with all our CRT HUD projects, we fully participate in HMIS. Outcome measures include: 90% of participants will retain or exit to permanent housing at the end of the operation year and 88% of participants age 18 and older will maintain or increase their total income, with the caveat that younger participants (age 18-24) are often in training or education programs that decrease their time for employment. This, in turn, can affect their income, possibly bringing down the overall percentage in this category.
