3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

BHcare Rental Assistance a merger of two Rental Assistance projects. The combined project is a Housing First project that will serve 31 homeless, disabled adults with mental illness. Priority is given to serving individuals who have experienced chronic homelessness and need supports to maintain housing stability and improve the quality of their lives. In addition to 31 scattered site units, the former Harbor Housing Opportunities program offers 2 two bedroom units in an agency owned apartment complex. CoC support is needed to ensure that housing is available to everyone that is eligible. Rental Assistance is operated as a permanent scattered site program. Lease agreements are signed with individual landlords. This project assists the community in addressing the local homeless situation, by providing housing and services to the population, which in turn lessens the amount of ER visits. BHcare partners in the Greater New Haven Coordinated Access Network resulting in a regional wait list populated and maintained with information on the homeless population. We are also partnered with the local Veterans Administration to assist the homeless veterans' we serve. BHcare coordinates and participates in the annual HUD Point in Time count. BHcare aims to ensure housing retention and assist participants with increasing their current income and obtaining needed benefits by providing the following services. Clients are encouraged to participate in programs offered by the agency but are reminded that participation is voluntary and does not affect their housing. Resulting from the partnership between housing and support services, 95% participants are expected to remain in or exit to permanent housing during the operating year, and 80% of household members are expected to maintain or increase household incomes.

BhCare Rental Assistance 1 was a merger of several projects. The combined project is a Housing First project that serves 23 homeless, disabled adults with mental illness. Priority is given to serving individuals who have experienced chronic homelessness and need supports to maintain housing stability and improve the quality of their lives. In addition to 23 scattered site units, the former Harbor Housing Opportunities program offers 2 two bedroom units in an agency owned apartment complex. CoC support is needed to ensure that housing is available to everyone that is eligible. Rental Assistance is operated as a permanent scattered site program. Lease agreements are signed with individual landlords. This project assists the community in addressing the local homeless situation, by providing housing and services to the population, which in turn lessens the amount of ER visits. BHCare partners in the Coordinated Access Network resulting in a regional waitlist populated and maintained with information on the homeless population. We are also partnered with the local Veterans Administration to assist the homeless veterans' we serve. BHCare coordinates and participates in the annual HUD Point in Time count. BHCare aims to ensure housing retention and assist participants with increasing their current income and obtaining needed benefits by providing the following services. DMHAS funded Case Management will be offered to all eligible participants along with outpatient Clinical Services, which include psychiatric, and substance abuse evaluations, individual and group psychotherapy, medication management, 24 hour mobile crisis unit and intensive outpatient programs for those with co-occurring disorders. Case management services provide skill building, ongoing support, assessments, coordination of services, referrals, and advocacy on behalf of the clients/tenants served. Vocational services are available to assist with the skills needed to obtain meaningful employment. Jail Diversion Services, provides clinical evaluations and case management services to court referred, pre-trial individuals. Other services offered by BHCare, Inc are: Employment/Vocational Services, local food banks, Social Rehabilitation Services, and Domestic Violence Services. Onsite benefits counselor will assist participants in obtaining all benefits, including SSI, SSDI, SAGA, SNAP and medical insurance. Clients are encouraged to participate in programs offered by the agency but are reminded that participation is voluntary and does not affect their housing. Resulting from the partnership between housing and support services, 95% participants are expected to remain in or exit to permanent housing during the operating year, and 80% of household members are expected to maintain or increase household incomes.

BHcare rental Assistance 2 is a Housing First project that serves 8 chronically homeless, disabled adults with mental illness 25 % of this project targets chronically homeless,disabled veterans. CoC support is needed to ensure that housing is available to everyone that is eligible. Specific Program Outcomes are: 1. Persons remaining in permanent housing as of the end of the operating year or exiting to permanent housing (subsidized or un-subsidized) during the operating year. The target is 100%. 2. Persons age 18 and older who maintained or increased their total income (from all sources) as of the end of the operating year or program exit. The target is 100%. SHP'11 is a permanent tenant based, scattered site program. Lease agreements are signed with individual landlords. SHP'11 assists the community in addressing the local homeless situation, by providing housing and services to the population, which in turn lessens the amount of ER visits. BHcare partners in the Coordinated Access Network resulting in regional wait list populated and maintained with information on the homeless population. We are also partnered with the local Veterans Administration to assist the homeless veterans' we serve. BHcare coordinates and participates in the annual HUD Point in Time count. BHcare aims to ensure housing retention and assist participants with increasing their current income and obtaining needed benefits by providing the following services. DMHAS Case Management will be offered to all eligible participants along with outpatient Clinical Services, which include psychiatric, and substance abuse evaluations,individual and group psychotherapy, medication management, 24 hour mobile crisis unit and intensive outpatient programs for those with co-occurring disorders. Tobacco Cessation programs are available upon request. Primary Care and Behavioral Health Integration Program. (Health Management Strategies for Recovery), providing health risk screenings, primary health care visits, nutrition counseling, wellness planning, educational curriculum's and peer health mentoring. Case management services provide skill building, ongoing support, assessments, coordination of services, referrals, and advocacy on behalf of the clients/tenants served. Vocational services are available to assist with the skills needed to obtain meaningful employment. Jail Diversion Services, provides clinical evaluations and case management services to court referred, pre-trial individuals. Other services offered by BHcare, Inc are: Employment/Vocational Services, local food banks, Social Rehabilitation Services, and Domestic Violence Services. Onsite benefits counselor will assist participants in obtaining all benefits, including SSI,SSDI,SAGA, SNAP and medical insurance.
