3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

Chrysalis Center's Family Matters program provides permanent supportive housing rental assistance and case management services to 10 households, 8 families with children and 2 individuals, who meet the HUD definition of homelessness and are disabled due to severe mental illness, chronic substance abuse, co-occurring disorders, or HIV/AIDS. Support services are available in the towns of West Hartford, Bloomfield, and Wethersfield, Connecticut. Chrysalis Center participates in coordinated access. CoC support is needed because affordable housing in these communities will not be possible without a rental subsidy for the population served. Chrysalis Center also uses housing first model. Housing is provided in scattered-site apartments located near public transportation, grocery shopping, churches, schools, and other community resources. Support services are provided at Chrysalis Center's main location or at individuals' homes. Chrysalis staff works in partnership with individuals to develop an Individual Recovery Plan (IRP). Participants choose self-identified service planning goals, including: accessing physical and mental health care; obtaining job skills training and education needed for employment; accessing child care and school enrollment; and finding employment. Case managers provide support for individuals to apply for Federal and State entitlement benefits; and provide connection to employment training, education, and employment resources, such as CT Works and other jobs training/employment or educational programs; and provide individuals linkage to substance abuse treatment, healthcare providers, mainstream community resources; and greater connectivity to natural supports; and to group and individual counseling. There is a critical community need for PSH to serve CH persons in the region. This project follows HUD Notice CPD-14-012 to prioritize serving CH families w/the longest history of homelessness & most severe service needs in the order indicated in the notice. During the intake process, staff work w/tenants to identify housing needs/preferences & locate a suitable unit. All tenants complete a full assessment within 30 days of entry & a service plan focused on ensuring tenants understand lease obligations, have income & are connected to needed services to address medical/behavioral health issues that may impede housing stability. Family Matters will continue to participate in HMIS. Family Matters addresses the need in the community for safe, decent, affordable housing; and provides the support services needed for individuals' recovery and increased self-sufficiency. Performance Measure Outcomes for Family Matters include: Housing Measure – 27 of 30 (90%) persons will remain in permanent housing at the end of the operating year; Income Measure – 9 of 10 (90%) will maintain or increase income from all sources by the end of the operating year.
