Greater Hartford Chrysalis Rental Assistance had an increase in tenant rental contribution within the expired grant term. Also, the infusion of CABHI into Greater Hartford Chrysalis Rental Assistance, created more of a challenge to house due to their chronically homeless status and lack in engagement.

3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

Greater Hartford Chrysalis Rental Assistance provides case management services and permanent supportive housing subsidies to 95 individuals, which includes 16 Veterans, who meet the HUD definition of chronic homelessness and who are disabled due to severe mental illness, chronic substance abuse, co-occurring disorders, or HIV/AIDS. Support services are available in the towns of Avon, Berlin, Bloomfield, East Hartford, Farmington, Hartford, Manchester, Newington, Rocky Hill, Simsbury, West Hartford, and Wethersfield, Connecticut. Chrysalis Center fully participates in the coordinated access network (CAN) & HMIS. Chrysalis Center also uses housing first model. Housing is provided in scattered-site apartments located near public transportation, grocery shopping, churches, schools, and other community resources. Support services are provided at Chrysalis Center’s main location or at the participants’ home. Plan for identifying housing needs is through a detailed assessment of each chronically homeless applicant. There is a critical community need for PSH to serve CH persons in the region. The 2018 PIT counted 521 people experiencing homelessness, and among them, 412 were homeless adults.

This project prioritizes CH persons with the longest history of homelessness & most severe service needs in the order indicated in the notice. All tenants complete a full assessment within 30 days of entry & a service plan focused on ensuring tenants understand lease obligations, have income & are connected to needed services to address medical/behavioral health issues that may impede housing stability. Chrysalis staff works in partnership with the participant to develop an Individual Recovery Plan (IRP). Participants choose a self-identified planning goal, including accessing physical & mental health care; obtaining job skills training and education needed for employment; and finding employment.
