

3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

Homes Plus provides scattered site subsidized permanent housing with its operating office at Holy Family Home and Shelter in Willimantic, CT. Case management is provided for target population CH, DV, PD, MI, and SA (10 units of 4 singles and 6 families with 22 beds, all of whom are homeless on entry and have a disabled member in the unit.) Case management services help clients with housing search and placement, collaboration with landlords and tenants, referrals, special needs, life skills coaching, lease compliance coaching, benefit advocacy, transportation as needed, food baskets and personal gifts for holidays, moving costs, outreach, assessment of needs, and utility deposits. Services are provided either at the resident’s home or the Homes Plus office, as appropriate. The goals of the program are stable housing, income, self-actualizing achievements, and better mental and physical health. 90% of persons will remain in permanent housing as of the end of the operating year. 90% of persons age 18 – 61 will maintain or increase total income from all sources as of the operating year or exit. Collaborators, that is, Holy Family Home and Shelter, Access Agency, WRCC, Windham and Natchaug hospitals, WAIM, United Services, Soup Kitchen, Willimantic Police, No Freeze Shelter, Generations, EASTCONN, PPI. The client and the case manager work together in on-going assessments. The program participates in HMIS and the Windham Coordinated Access Network which obtains referrals from the Coordinated Access Network system which identify people who have been homeless the longest and have the most severe service needs. This area has a substantial unserved homeless population in a rural area without many resources; that is, mental health and domestic violence, substance abuse, lack of transportation, lack of suitable employment. Homes Plus has a Housing First policy with ready access to the program without pre-requisites other than being chronically homeless and one member of the household having a disability. The CoC helps to direct activities and aimed at reducing homelessness. CoC support is needed to help maintain high standards and evaluate our program.

3C. Dedicated Plus

Dedicated and DedicatedPLUS

A “100% Dedicated” project is a permanent supportive housing project that commits 100% of its beds to chronically homeless individuals and families, according to NOFA Section III.3.b.

A “DedicatedPLUS” project is a permanent supportive housing project where 100% of the beds are dedicated to serve individuals with disabilities and families in which one adult or child has a disability, including unaccompanied homeless youth, that at a minimum, meet ONE of the following criteria according to NOFA Section III.3.d:

- (1) experiencing chronic homelessness as defined in 24 CFR 578.3;
- (2) residing in a transitional housing project that will be eliminated and meets the definition of chronically homeless in effect at the time in which the individual or family entered the transitional housing project;
- (3) residing in a place not meant for human habitation, emergency shelter, or safe haven; but the individuals or families experiencing chronic homelessness as defined at 24 CFR 578.3 had been admitted and enrolled in a permanent housing project within the last year and were unable to maintain a housing placement;
- (4) residing in transitional housing funded by a joint TH and PH-RRH component project and who were experiencing chronic homelessness as defined at 24 CFR 578.3 prior to entering the project;
- (5) residing and has resided in a place not meant for human habitation, a safe haven, or emergency shelter for at least 12 months in the last three years, but has not done so on four separate occasions; or
- (6) receiving assistance through a Department of Veterans Affairs(VA)-funded homeless assistance program and met one of the above criteria at initial intake to the VA's homeless assistance system.

A renewal project where 100 percent of the beds are dedicated in their current grant as described in NOFA Section III.A.3.b. must either become DedicatedPLUS or remain 100% Dedicated. If a renewal project currently has 100 percent of its beds dedicated to chronically homeless individuals and families and elects to become a DedicatedPLUS project, the project will be required to adhere to all fair housing requirements at 24 CFR 578.93. 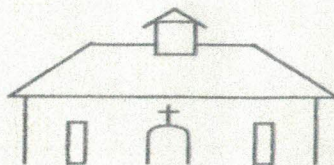
