3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

HOPE I and II is a Housing First program and provides nine units of project-based permanent supportive housing and two units of tenant-based supportive housing with rental subsidies. In this reporting year, 11 households were being served and all persons served were reported in HMIS.

Persons served in HOPE I and II included people with mental health, co-occurring diagnoses, physical disabilities and domestic violence. The program target population is predominately families. On site case management and unlimited assistance is provided to program participants including assessment of service needs, life skills training, referrals to mental health, substance abuse and outpatient health services, obtaining entitlements, increasing financial support and encouraging /assisting with employment. Participants graduate from HOPE program to other permanent subsidized housing or traditional independent housing when they become self-sufficient and no longer require case management services. Financial support through yearly HUD renewals is necessary to continue housing homeless families and individuals in Litchfield County.

HOPE Program service provider and housing owner are officers on the local Continuum of Care which has become a non-profit company. Becoming non-profit provides the opportunity to secure other funding sources to serve the needs of the homeless not currently served through Federal grants for the chronically homeless only.

The local Continuum of Care is a coordinated access partner with Waterbury Continuum of Care and we actively work together.

To further facilitate a local point of entry for homeless individuals in our coordinated access network, the Continuum of Care has secured a site for a drop-in-center (The Gathering Place). The Gathering Place facilitates the delivery of services: social, employment, medical, mental-health, substance abuse, education and CAN assessments for housing and housing resources.

The residential sites for HOPE I and II clients are all located in the City of Torrington, CT. Two project-based sites are located on South Main Street (housing 7 families), another project-based site is located on James Street (housing two families) and the two tenant-based sites are located in Torrington as well.

Project outcomes include: 86% of participants will remain in permanent supportive housing; 93% of participants will remain or increase total income (from all sources).

HOPE Program is supported by the CoC because it addresses community need to end family homelessness in Litchfield County and to assist participants to increase income, locate affordable housing and build life skills. HOPE Program is an essential part of the CoC strategy to end family homelessness.

This is in response to your request of June 17, 2004, regarding your organization's tax-exempt status.

In May 1942 we issued a determination letter that recognized your organization as exempt from federal income tax. Our records indicate that your organization is currently exempt under section 501(c)(3) of the Internal Revenue Code.

Based on information subsequently submitted, we classified your organization as one that is not a private foundation within the meaning of section 509(a) of the Code because it is an organization described in sections 509(a)(1) and 170(b)(1)(A)(iii).

This classification was based on the assumption that your organization's operations would continue as stated in the application. If your organization's sources of support, or its character, method of operations, or purposes have changed, please let us know so we can consider the effect of the change on the exempt status and foundation status of your organization.

Your organization is required to file Form 990, Return of Organization Exempt from Income Tax, only if its gross receipts each year are normally more than \$25,000. If a return is required, it must be filed by the 15th day of the fifth month after the end of the organization's annual accounting period. The law imposes a penalty of \$20 a day, up to a maximum of \$10,000, when a return is filed late, unless there is reasonable cause for the delay.

All exempt organizations (unless specifically excluded) are liable for taxes under the Federal Insurance Contributions Act (social security taxes) on remuneration of \$100 or more paid to each employee during a calendar year. Your organization is not liable for the tax imposed under the Federal Unemployment Tax Act (FUTA).

Organizations that are not private foundations are not subject to the excise taxes under Chapter 42 of the Code. However, these organizations are not automatically exempt from other federal excise taxes.

Donors may deduct contributions to your organization as provided in section 170 of the Code. Bequests, legacies, devises, transfers, or gifts to your organization or for its use are deductible for federal estate and gift tax purposes if they meet the applicable provisions of sections 2055, 2106, and 2522 of the Code.


Your organization is not required to file federal income tax returns unless it is subject to the tax on unrelated business income under section 511 of the Code. If your organization is subject to this tax, it must file an income tax return on the Form 990-T, Exempt Organization Business Income Tax Return. In this letter, we are not determining whether any of your organization's present or proposed activities are unrelated trade or business as defined in section 513 of the Code.

Section 6104 of the Internal Revenue Code requires you to make your organization's annual return available for public inspection without charge for three years after the due date of the return. The law also requires organizations that received recognition of exemption on July 15, 1987, or later, to make available for public inspection a copy of the exemption application, any supporting documents and the exemption letter to any individual who requests such documents in person or in writing. Organizations that received recognition of exemption before July 15, 1987, and had a copy of their exemption application on July 15, 1987, are also required to make available for public inspection a copy of the exemption application, any supporting documents and the exemption letter to any individual who requests such documents in person or in writing. For additional information on disclosure requirements, please refer to Internal Revenue Bulletin 1999 - 17.
