3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

New Opportunities, Inc. (NOI) proposes to provide permanent supportive housing opportunities for families with children that are infected or affected by HIV/AIDS in Meriden, CT. NOI uses a housing First Approach when providing these services. In 2016, 10,400 people were living with HIV disease in Connecticut (291 per 100,000 people) according to the Department of Public Health (DPH).

In 2016 the DPH reported 269 new cases of HIV were diagnosed in Connecticut residents (7.5 per 100,000 people). Of the newly diagnosed cases, 70 (26%) were diagnosed with AIDS within a year their HIV diagnosis. In the city of Meriden 58 individuals diagnosed with HIV in 2015. Overall, Meriden has 288 diagnosed cases in total. Between 2012 and 2016 Meriden had 18 new diagnosed cases of people living with HIV.

The project will provide three scattered site housing units in Meriden. The targeted program population will be referred from either homeless shelters or other social service agencies. NOI's SHP is designed to provide housing and supportive services to enable homeless persons to live as independently as possible. The program assists participants in securing permanent housing while providing the additional services needed to live in a healthy and safe environment. The programs overall goals that are made possible by the COC's assistance are as follows: achieve residential stability, increase their skill levels and/or incomes, and obtain greater self-determination.

The service needs of the population will be met through a holistic case management delivery system which looks at both strengths and barriers for each participant. A comprehensive case plan is developed which builds upon strengths and provides supports for barriers facing the participant including linkages to education/training programs, state benefit assistance, disability benefits, transportation, and mental health/substance abuse services. The project participates in HMIS and all participants are determined eligible for services. NOI will also include a variety of collaborations and partnerships within the case management services to ensure each participant receives the services needed to overcome barriers. To help participants increase skills and/or income we work to identify and address barriers, and develop a plan that ultimately results in securing an income to live as independently as possible.

These barriers require continuous treatment and intensive case management before a client is stable enough to participate in job development and employment. NOI's goal is to have 100% of the participants remain and/or exit to permanent housing while maintaining and/or increasing total income. In the event that the client in the Supportive Housing Program is disabled the assigned NOI case workers will examine additional avenues of support including state or federal assistance. Without HUD support NOI does not have the additional funding and these critical services will be in jeopardy.
