3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

This funding supports leasing expenses for 24 units (28 individuals served) in scattered site housing in Manchester for homeless individuals. CoC support is needed for rental assistance and to partially fund supportive services and well as for administrative costs. The target population is disabled (with severe and persistent mental illness), homeless single adults with severe mental illness, some of whom are also chronic substance abusers (co-occurring disorders), however some of these individuals are families. All units are prioritized for those who are chronically homeless. Since November 2014, referrals for supportive housing units have come directly from the Greater Hartford Coordinated Access Network. CHR is an active participant in coordinated access in Greater Hartford. We are coordinating with the Town of Manchester Senior, Adult and Family Services Department, Eastern CT. Health Network (Manchester Hospital), Worksource (Employment support) and the MACC (shelter and food pantry).

The goals of the program include recruiting eligible individuals to obtain housing and assisting participants to 1) maintain residential stability 2) increase skills and income including increased income through employment or obtaining benefits/entitlements and 3) realize greater self-determination through individualized service plans with goals related to residential stability, skill development and access to resources.

Program outcomes will be 1. Persons remaining in permanent housing as of the end of the operating year or exiting to permanent housing (subsidized or unsubsidized) during the operating year(target is 93%) and 2.) Persons age 18 and older who maintained or increased their total income (target 93%) (from all sources) as of the end of the operating year or program exit.

Services provided by the sub-recipient include assessment of service needs, case management, housing search/counseling and life skills training. CHR participates in HMIS and utilizes a housing first approach.
