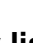

Project Home is a permanent supportive housing program using the Housing First model. Offers immediate access to housing without prerequisites of sobriety, etc. Participants have leases in their own name and have the same tenancy rights as others in the community. WRCC is located at 872 Main Street, Willimantic, CT and serve homeless, disabled singles (12) and families (5). NOTE: This application was initially approved for 25 % of households are chronically homeless. Going forward, Project Home will accept only chronically homeless households.

All participants meet HUD's definition of homelessness. Disabilities of participants include serious mental illness & chronic addiction.

Windham county has 2 family shelters, 1 shelter for adults operating November-April and 2 domestic violence shelters. This county has a great need for affordable housing as despite best efforts of WRCC & other local providers, there is still a considerable number of homeless households facing housing barriers.

Project Home will identify eligible applicants via the Northeast CANs. After CAN staff identify eligible households by using diversion & VI-SPDAT screening tools at Intake, applicants will be placed on the By Name List in HMIS. Wait-listed applicants will be placed into permanent supportive housing as vacancies arise and according to their score on the VI-SPDAT and length of time homeless.

Project Home provides supportive services & subsidized rents to participants at scattered sites apartments and is part of a CoC as these funds support the financial viability of this project by providing leasing and support service dollars. Project Homes participates in the HMIS system to document all required information. All participants are expected to pay monthly rent equivalent of no more than 30% of households income.

Project Home staff performs housing placement and service plans for all participants; and provide ongoing supportive services to participants throughout their tenure in the program. Support services include but are not limited to: transportation, assessment of service needs, case management, housing search and counseling services, life skills training, education services, budgeting, and assistance maintaining successful landlord/tenant relationships. Participants with substance abuse and/or mental health needs will be referred by case managers to agencies including but not limited to United Services, Inc., Perception Programs, Inc., Natchaug Hospital, and Generations Family Health Center.

MEMORANDUM OF UNDERSTANDING
Generations Family Health Care and Windham Regional Community Council, Inc.

The purpose of this Memorandum of Understanding is to encourage cooperation between Generations Family Health Care and Windham Regional Community Council, Inc.'s (WRCC) Permanent Supportive Housing Program Project Home and to describe the roles and responsibilities of each party.

Project Home is a permanent supportive housing program employing the Housing First Model, located at 872 Main Street, Willimantic, CT which offers immediate access to housing without prerequisites of sobriety, lack of criminal history, income or other factors that contribute to homelessness. Participants have leases in their own name and have the same tenancy rights as others in the community. Haven serves 12 chronically homeless disabled individuals and 5 chronically homeless families whose head of household is disabled. All entering participants meet HUD's definition of chronic homelessness and are from emergency shelters or places not meant for human habitation. Disabilities participants have include mental illness and chronic addiction. Haven identifies eligible applicants through the Northeast Coordinated Access Network (CAN). WRCC participates in the HMIS system to document all required information. All participants are expected to pay monthly rent equivalent of no more than 30% of the household income. Project Home is part of a CoC as these funds support the financial viability of this project by providing leasing and support service dollars.


Project Home staff perform outreach housing placement and service plans for all participants and provide ongoing supportive services to participants throughout their tenure in the program. Support services include but are not limited to: assessment of service needs, case management, housing search and counseling services, life skills training, education services, transportation, assistance completing forms for state and federal benefits, assistance obtaining and maintaining successful landlord/tenant relationships. Participants with substance abuse and/or mental health needs will be referred to agencies including but not limited to United Services, Inc., Perception Programs, Inc., Natchaug Hospital, and Generations Family Health Center.

Generations agrees to donate in-kind primary and preventative health care and dental services to clients in WRCC's Project Home program. Generation's federal Health Care for the Homeless program provides a continuum of health care services to homeless individuals residing in shelters, transitional housing and the street. The Health Care for Homeless program serves as a primary referral source for WRCC's Project Home program to link them with a medical home.

Generations expects to provide an approximate total of \$56,000 in in-kind funds for the Project Home program. We anticipate these services to be available on July 1, 2019.

All parties agree to advise one another of pertinent matters in the delivery of services and understand that each is bound by confidentiality standards regarding the exchange of program participant information. Appropriate releases will be secured when confidential client information needs to be shared.

There shall be no discrimination of any person or group of persons on account of race, color, creed, religion, sex, marital status, sexual orientation, age, handicap, ancestry or national origin in the delivery of services or operation of the project.
