Tenants pay 30% of the rent based on their income which left unspent funds. Because of the success of tenants maintaining or increasing their income the funds were not able to be spent although we did serve two extra tenants.

3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

This is a Rental Assistance TRA program that is scattered site. This project merged with CT0264 and this is the surviving grant. The program sub-recipient, United Services, Inc., is a non-profit entity. There are 10 rental subsidies for 1 bedroom apartments. These apartments are located within our 21 town service area that includes all of Windham County and parts of Tolland county. This program addresses homelessness in our communities by providing permanent, affordable housing and the services to help participants maintain their housing. This program will only serve eligible participants who meet the HUD definition of homelessness and are disabled. The eligible disabilities are mental illness, substance abuse or a combination of the two. Vacancies will be filled with chronically homeless from the Northeast Homeless Registry. The participants receive supportive services through referrals to our own agency or by referrals to our community partners. United Services provides many of these services including mental health and substance abuse treatment as well as case management, housing search and counseling, moving, assistance with moving costs and utility deposits, needs assessments, life skills, and vocational counseling. In addition, our community partners who have provided letters of support provide the following services: Perception Programs and the Hartford Dispensary provide substance abuse services; Day Kimball Hospital and Natchaug Hospital provide both mental health and substance abuse services; Generations Family Health Center provides medical and dental care and WRCC provides AIDS counseling. Program goals are to increase housing stability and maintain or increase income for program participants. This program participates in HMIS, the coordinated access network and is "housing first". Without COC funding this project would not be able to house these individuals. In the previous year the project had a goal of 89% housing stability and achieved 100%. The income goal was set at 100% and was met. Six participants are now chronically homeless.


