This is a Rental Assistance PRA program with 12 rental subsidies for 1 bedroom apartments for individuals with mental health and/or substance abuse problems. The project sub-recipient, United Services, Inc. is a non-profit entity. These apartments are located at Brick Row Apartments at 25 Vermont Drive in Willimantic, CT. This program addresses homelessness in our community by providing permanent, affordable housing and the services to help participants maintain their housing. This program serves only eligible participants who meet the HUD definition

of homelessness and are disabled. All future openings are set aside for chronically homeless people on the Northeast CT homeless registry. The eligible disabilities are mental illness, substance abuse or a combination of the two. Case management services are available on site. The participants receive supportive services through referrals to our own agency or by referrals to other community providers. United Services provides many of these services including assessment, mental health and substance treatment as well as case management, housing search and counseling, help with moving, help with utilities, life skills and vocational counseling. In addition, other community agencies provide the following services: Perceptions Programs and the Hartford Dispensary provide substance abuse services; Day Kimball and Natchaug Hospitals provide both inpatient and outpatient mental health and substance abuse services; Generations Family Health Center provides medical and dental care; and WRCC provides AIDS counseling. The goals of this program are to increase housing stability and to maintain or increase income for the program participants. 100% achieved housing stability and 94.12% (16 of 17) maintained or increased income. This program participates in HMIS, the Coordinated Access Network and is "Housing First". Without COC funding we would not be able to provide housing to these individuals.


