Explain the circumstances that led HUD to recapture funds from the most recently expired grant term related to this renewal project request.

Numerous tenants either obtained or increased their income, which lowered the housing assistance payments and increased tenant portion of rents. Time lapse (1-2 months) when housing new tenants also impacted recapturing of funds. The project will manage its budget in an effort to maximize utilization of the award amount, in order to house additional people and minimize fund recapture.

3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

The Combo grant provides a total of 42 tenant based, scattered site rental certificates consisting of: (4) certificates for efficiencies; (26) certificates for 1Br's; and (12) certificates for 2Br's. This project has a capacity to provide a total of 64 beds including (30) CH beds designated to single individuals issued certificates for efficiency and/or 1Br and (34) beds designated for adults with children issued family certificates for 2Br's. This project has managed its budget to support (1) extra single individual with a 1Br certificate. All households with no children and heads of households with children have severe mental health and/or addiction disorders. All persons are offered DMHAS funded Pilots services, which are contracted to Reliance House, Inc, Sound Community Services, Inc. and The Connection, Inc. Pilots services consists of case management, needs assessment, employment, education, life skills, housing, counseling, outreach, crisis intervention, budgeting, transportation, basic needs and linkage to other services such as medical, legal, child care, housing resources for security deposit/utility deposits, and outpatient services based on individual needs. In addition to contracting to Pilots services, this project closely networks with numerous non-profit and state agencies to ensure that the needs of participants are met. The project obtains referrals from the Coordinated Access Network entry system and participates in regional outreach efforts to identify persons who have been homeless the longest and who have the highest service needs. The project uses a Housing First Model and offers immediate housing without prerequisites. Participants have leases in their own name and the same tenancy rights as others in the community. Staff is in frequent contact with landlords and tenants to avoid and address lease violations. Project outcomes include: 92% of tenants will remain in permanent housing or exit to permanent housing and 91% of adults will maintain or increase their income from any source. This project is supported by the CoC because it addresses the community's need for CH designated beds specialized services for persons with serious mental health and/or addiction disorders. This project leverages mainstream resources to maximize client income and provides a full array of services and relies on CoC funding to support activities that cannot be funded through other sources. This project is also an HMIS participant.
