3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

Our DV shelter operating at >100% capacity for the past 8 years; and the slow economic recovery in NLC preventing homeless victims of DV from finding employment and affordable housing; NLC needs a transitional housing program (TH) for victims of DV, sexual assault, stalking and trafficking.

Phoenix House (PH) is a TH with a population focus on persons fleeing DV. Located in a single site, PH uses operating funds to provide a total bed capacity of 29 in 9 apartments: 2 for single victims and 7 for victims & their children. All units are fully furnished. Laundry facilities and a security system, monitored 24/7, is on-site. On-call advocates provide after-hours support. Community amenities such as schools, libraries, houses of worship, grocery stores, doctors, dentists, parks and recreation are located within walking distance or short bus rides.

Outreach services are continuous. Participants come from DV and homeless emergency shelters in NLC, or across CT. While no beds are specifically designated other than for DV, sexual assault, stalking, and trafficking, participants include persons who are chronically homeless, have HIV/AIDS, and/or are severely mentally ill, chronic substance abusers, physically disabled, or developmentally disabled.

Performance measures are: a) 90% of persons will exit to permanent housing; and b) 40% of persons age 18 and older will increase their earned income from entry to exit/follow-up.

Adult residents have access to weekly, on-site case management, including assessment of service needs, goal setting, case plan monitoring, life skills training, housing search and counseling, and referrals to community services. Assistance with moving costs, utility deposits, transportation, food, clothing, and household and personal care items, is provided as needed. Agreements with partner agencies, Coordinated Access Network for housing and CT Legal Services for legal services, prioritize PH residents for those services. Education, mental health, outpatient health, and substance abuse treatment are provided by collaborative agencies by referral. An on-site Career Center provides computers and internet access for educational and vocational purposes. A Career Specialist offers employment assistance and job training. Residents participate for up to 24 months and pay 30% of their income in rent. PH is a Housing First program.

A dedicated Child and Family Services Advocate assists families to enroll children in school and ensure access to education services such as preschool, after-school, vacation, and enrichment activities; school supplies; and uniforms. Federal and state laws prohibit participation in HMIS, but we have a comparable data-base and are active in our CAN and have led coordinated access at the local and state levels. Because state funding, private grants and fundraising do not cover the cost of operating the PH program, CoC program support is essential for its continuation.
