

### 3B. Project Description

**1. Provide a description that addresses the entire scope of the proposed project.**

Thames River Family Program, located in Norwich, is a TH for 24 families headed by parenting youth, 18-24 years of age. We have moved toward an all Youth Program; families are headed by parents under 25, as there is no other program in our region that works strictly with families headed by parenting youth. All participants will be homeless and eligible for the program based on HUD's definition of homelessness. We will embrace a Housing First approach. Some families also may be experiencing domestic violence and/or have substance issues; all necessitate a need for a transitional program to acquire skills to be ready to move to and sustain permanent housing. The program participates in HMIS and has since the system's inception. We participate in our region's Coord.Access Network; all referrals come through this process. Families reside in 24, 2 and 3 br units while they work with staff to identify needs and pursue goals for increased skill level and income e.g., financial literacy, employment skills, improved tenancy skills, effective parenting skills. Our Advocates work with families to ensure that children are enrolled in school and that their individual educational needs are identified and being addressed. We work closely with area schools and their homeless liaisons. Our families utilize an onsite licensed and nationally accredited childcare center, but children also are referred to Head Start and other school readiness programs. The agency participates in a number of local, regional and statewide committees that work together to create a network of service provisions to meet the identified needs of the people in this region, and work directly with community agencies to support individuals in acquiring services to become successfully independent. Collaborations will occur with local and regional treatment and mental health agencies, Safe Futures of Southeastern Connecticut for domestic violence issues; the Eastern CT Workforce Investment Board for employment services; and Alliance for Living, the regional AIDS/HIV service agency. Residents will be helped to access mainstream resources, eg., cash and non-cash benefits. The COC support assures that we stay HUD compliant and work as a network to end homelessness, thus supporting the community's need for support so families can be quickly and successfully housed. We have been working successfully towards shortening the lengths of stay for those households who can successfully transition from TRFP to their own places with sustainability. We have a more intensive relationship with an increasing number of housing authorities and landlords to help expedite families' move to permanent housing. We also have been very successful helping families overturn housing denials, leaving them with more housing options. We anticipate that 90% of our families will leave TRFP for permanent housing; with more than 60% increasing their income.
