3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

The Homeless Collaborative Network provides PSH to 25 families and 25 singles in New London County, CT and operates under the Housing First model. Housing is scattered site apartments in New London County. The TVCCA PSH Program provides housing search, moving assistance, landlord mediation, utility assistance, nutritional support, health care, and counseling services. The admission criteria include homelessness and a permanent disability. All vacancies are prioritized for chronically homeless singles and families. Each participant household is matched with a case manager to facilitate the attainment of mainstream benefits and services. TVCCA participates in the local C.A.N. Referrals to other agencies are facilitated. We participate in HMIS and have 100% of our PSH participants entered into the system. This project is a vital piece of the Southeastern Connecticut continuum of care. Our current By-name Registry shows that there are still homeless singles and families who have been identified as permanent supportive housing candidates.

This PSH program remains a key component of our plan to end homelessness in New London County, CT. Because of the financial and programmatic support offered by HUD, 50 households have maintained safe, stable housing. Our Continuum of Care, CT BOS, provides yearlong support to our project with technical assistance, guidance on new rules and assistance with preparing our annual response to the HUD NOFA. Without these supports, 50 households would be sent into crisis and likely be re-entering homelessness. This project is vital; there is still unmet need in our community for PSH. It is with deep gratitude that we request HUD's continued support of our housing success story.

We will continue our partnerships in the community with organizations such as United Community & Family Services and Alliance for Living to provide holistic, well-rounded services to PSH participants.

With the housing and case management supports provided by HUD, many of our participants have enjoyed stable housing. This program was and is the key to stopping a never ending cycle of homelessness.

Progress will be reported via the following outcome measures:

1) 96% of participants will remain in PSH or exit the program to permanent housing (subsidized and unsubsidized).

2) 90% of participants will maintain or increase their overall income while in the program or at program exit.

All vacancies are filled from the Southeastern CT Coordinated Access Network (SECT CAN).
