35 certificates, scattered site supportive housing project (22 1-bedroom units (individuals) and 13 for families - 8 2-bedroom, and 5 3-bedroom units) with lease held by participant who pays 30% of adjusted income as rent to the landlord. COMMUNITY NEED: The 2018 PIT revealed 161 people in shelters & places not meant for human habitation in New Britain, 33 of which were children. New Britain's March 2018 unemployment rate of 6.2% and poverty of rate of 22.9% exceeded the national rates of 3.8% and 14% exceeded the national rates of 3.8% and 14%. TARGETED POPULATION: chronically homeless individuals and families with a member with a physical, mental illness, domestic violence, &/or substance abuse disability. PLAN FOR ADDRESSING PARTICIPANTS IDENTIFIED HOUSING AND SERVICE NEEDS: via case managers and participants creating & following through on an Individualized Service Plan addressing disability, education, job search, mainstream benefits, & other issues raised. PROJECTED OUTCOMES: 1) 91% of persons either remain in or exit to permanent housing by the end of the operating year, 2) 54% of those 18 and older maintain or increase their total income at the end of the operating year or program exit, and 3) 85% of adult participants obtain or retain medical insurance at the end of operating year or program exit. COORDINATION WITH PARTNERS AND PARTICIPANTS BEING HELPED TO ACCESS MAINSTREAM RESOURCES: provided via collaboration between community partners; a participant & a case manager. With no limitation on length of stay except lack of lease provisions compliance, participants are encouraged to seek independent, permanent solutions through increased income, subsidized housing, etc. COC SUPPORT IS NEEDED: maintains fiscal integrity & stability of the program without which it could not operate. CoC Support requested for rental assistance, supportive services, HMIS, & administrative costs is \$548,776, with a \$138,000 cash & in-kind Match, & numerous in-kind supports. OUTREACH AND SERVICES TO BE PROVIDED: include supportive services for assessment of service needs, housing search & counseling services, case management, life skills training, outreach services, & transportation. Participants are encouraged to access to the very accessible bus line, mainstream resources, medical and psychiatric support, and other necessary services. 
