Transitional living program for 15 individuals dedicated to youth, with 5 dedicated to youth veterans. **COMMUNITY NEED:** The 2018 PIT revealed 161 people in shelters & places not meant for human habitation in New Britain, 33 of which were children. New Britain's March 2018 unemployment rate of 6.2% and poverty of rate of 22.9% exceeded the national rates of 3.8% and 14% exceeded the national rates of 3.8% and 14%. **TARGETED POPULATION:** single, homeless individuals with mental health issues, substance abuse issues, youth, veterans, & those that lack education and employment skills to maintain independent living. **PLAN FOR ADDRESSING PARTICIPANTS IDENTIFIED HOUSING AND SERVICE NEEDS:** via case managers and participants creating and following through on an Individualized Service Plan emphasizing hope, self-advocacy, peer support, recovery by choice, and self-sufficiency addressing disability, education, job search, mainstream benefits, and other barriers to housing. **PROJECTED OUTCOMES:** 1) 87% exiting will exit to permanent housing destinations during the operating year, 2) 55% will increase their total income (from all sources) as of the end of the operating year or project exit, and 3) 86% will obtain or retain medical insurance at the end the operating year or program exit. **COORDINATION WITH PARTNERS AND PARTICIPANTS BEING HELPED TO ACCESS MAINSTREAM RESOURCES:** provided via collaboration between community partners; a participant and a case manager. **COC SUPPORT IS NEEDED:** to maintain fiscal integrity and stability of the program without which it could not operate. CoC Support requested for operating and administrative costs is \$210,007, with a \$53,000 Cash Match, and numerous in-kind supports. **OUTREACH AND SERVICES TO BE PROVIDED:** includes case management services for all participants with direct case management, housing search and counseling services, life skills training, outreach services, and transportation. Case Managers' offices are conveniently located on the 1st floor of the same building. The concept of habilitation (teaching skills not present before) rather than rehabilitation is a focus of this program as it relates to successful independent living. Maximum stay is 24 months with shorter stays strongly encouraged. **THE NUMBER AND TYPE OF HOUSEHOLDS TO BE SERVED AT FULL CAPACITY:** 15 single individuals dedicated to youth, 5 of whom will be veterans. **THE SITE LOCATION AND TYPE OF HOUSING:** transitional living at 241 Arch Street, New Britain CT for 15 individual, private rooms with shared bathroom facilities and access to a full-service kitchen on the first floor including the ability to store refrigerated and cold storage shelf items. The Project **PARTICIPATES IN HMIS.** **PARTICIPATION IN COORDINATED ACCESS** is via the recipient as a major player in the Coordinated Access Network, seeking applications via the CAN and the Veterans' Administration, using a **LOW BARRIER, HOUSING FIRST APPROACH** prioritization.
