During our last grant term year, our Accountant became ill with cancer and subsequently died, and was unable to work to complete our first quarterly drawdown. Upon hiring a new Accountant, we were able to maintain our schedule of quarterly drawdowns.

4. Have any Funds been recaptured by HUD for the most recently expired grant term related to this renewal project request? Yes

Explain the circumstances that led HUD to recapture funds from the most recently expired grant term related to this renewal project request.

In the last grant term year, the program did not spend \$13,021 of the \$315,197 award amount. Our program participants maintained their income, and continued to consistently pay their portions of rent; additionally, the program was able to lease scattered-site units for participants at or below the FMR and maintain the projected number of households. In the following year, it is anticipated that the landlords will increase rents and more of our leasing funds will be expended.

3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

The St. Vincent DePaul Mission of Waterbury, Inc. (SVDP) is a 501(c) (3) nonprofit org. and operates the SOS Program (PSH leasing scattered-site). SOS Program staff offices are centrally located in Waterbury, open 24/7, and offer accessibility to participants, bilingual staff, and transportation, as needed. The SOS Program, working in conjunction with the CoC, Coordinated Access--Housing Placement Comm., Homeless Outreach Teams, our own shelter, and family shelter, will house and serve families and indiv's coming from the streets or shelters. All Heads of Households will be homeless/chronically homeless and disabled (with mental illness, often including substance abuse) as this targeted population is highly prevalent in the Waterbury community. Our 1-BR's are currently used by CH indiv's. Upon availability, the program will target turnover beds for CH families/indiv's, whenever possible. 67% of the funding requested will be utilized for leasing scattered-site units in integrated settings throughout Waterbury in 2-3-BR units and 7-2-BR units for families, and 11-1-BR units for indiv's in order to occupy existing housing stock in Waterbury--meeting the needs of the community, CoC, and participant preferences. Utilizing the Housing First Model, SOS will intake, and house as quickly as availability permits, providing services and coordination to promote housing stability, improved independence, and well-being. We anticipate serving at least 36 persons-9 families with 15 children, and 11 indiv's. Our housing will not be contingent upon compliance with services. SVDP will continue to lease units and our participants will sublease from us. Participants will choose units and neighborhoods within walking distance from bus lines, and near the services and community amenities they require. Our CoC program funding and supportive service expenditures are required to properly assist our MI disabled participants to improve stability, housing, income, reintegration, and recovery: Staff will continue to assess participants and develop ISP's biannually to identify needed services and resources. Households will continue to be trained in ind. living skills at least weekly, and assisted to apply for, obtain and maintain, and be transported, as needed, to healthcare, substance abuse, psychiatric services, and mainstream resources--SSA, DSS, VA. Households will be assisted in housing searches, job finding, and/or connected to local educational institutes/employment services, e.g., BRS, Kennedy Center, MHACHoices, One Stop Job Training Center, and DOL. Our performance outcomes include: 85% of our participants will remain in permanent housing; 85% of the adults will maintain/increase their income from all sources as of the end of the operating year; and 82% of our adult participants with mental health and substance abuse disorders will be referred to and/or participate in some form of recovery service. We will continue to utilize HMIS, and maintain all data quality.
