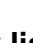

3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

This Rental Assistance Renewal project will continue to serve 15 chronically homeless individuals with mental health and/or substance use diagnosis, based on the community's need to provide housing and supportive services to homeless disabled individuals. Admission criteria dictates that individuals are experiencing documented chronic homelessness with a verified disability. The Housing Authority is the primary applicant for this project, with Center for Human Development (CHD) providing services to include case management, completion of housing process and activities to maintain housing, relapse prevention and vocational support, support around activities of daily living, transportation and counseling services, along with referrals to appropriate community providers. Danbury is part of the Balance of State Continuum of Care and participates in the Consolidated Access Network (CAN). The grant provides housing for 15 individuals and has been able to serve up to 18, using the Housing First model. These individuals will reside in project-based housing and/or scattered site housing. Applicants are identified via shelters or in other places not meant for human habitation. These providers are active members of the CoC, as well as participants of the CoC Screening Committee. The CoC's support is crucial because it maintains a universal wait list which keeps the process systemized. No street outreach is provided, but the agency participates in the point in time count and Project Homeless Connect where applications are received. The program will continue to serve all persons who meet the HUD definition of chronically homelessness upon admission. Individuals who need services outside the scope of what CHD PILOTS provides will be referred to other area providers including Western Connecticut Mental Health Network, Catholic Charities CSP, Homeless Outreach and AIDS Project Greater Danbury. CHD PILOTS will also work with Danbury Hospital and other mental health, substance use and employment agencies to ensure that all participants are connected with needed services. The participants will be assisted in increasing their income through help in applying for all eligible state and federal benefits including SAGA cash, SSI, SSDI, Medicaid, Medicare and SNAP. Case managers will assist individuals in connecting with the local labor department and Ability Beyond to get job training and job search skills. This tenant-based assistance allows participants a choice in where they wish to live in the Greater Danbury area while receiving support services and life enhancing skills. We will continue to enter participants into and utilize HMIS, and maintain our data quality at 100%. The projected outcomes of this project for the proposed grant year are that participants will remain in permanent housing or exit to permanent housing destinations and that participants will maintain or increase their total income.

Grantors and donors may rely on the determination that you are not a private foundation for your first two tax years, unless notice that you will no longer be treated as a section 509(a)(1) organization is published in the Internal Revenue Bulletin. However, a grantor or donor may not rely on such determination if he was in part responsible for, or was aware of, the act or failure to act that resulted in your loss of section 509(a)(1) status, or acquired knowledge that the Internal Revenue Service had given notice that you would be removed from classification as a section 509(a)(1) organization.

You are not liable for social security (FICA) taxes unless you file a waiver of exemption certificate as provided in the Federal Insurance Contributions Act. You are not liable for the taxes imposed under the Federal Unemployment Tax Act (FUTA).

Organizations that are not private foundations are not subject to the excise taxes under Chapter 42 of the Code. However, you are not automatically exempt from other Federal excise taxes.

Donors may deduct contributions to you as provided in section 170 of the Code. Requests, legacies, devises, transfers, or gifts to you or for your use are deductible under sections 2055, 2106, and 2522 of the Code.
