This project administers rental assistance based upon a percentage of participant's income. Therefore, a participant may not use the full funding available per certificate. In order to maximize all available funds, additional units are created when surplus funds are available. The project will continue to manage its budget to continue to house additional people as funding allows and minimize fund recapture.

3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

The project serves 13 individuals. The project will provide 11 furnished, permanent supportive housing units (efficiency units) at the Safe Haven apartment building in New Haven, CT and two scattered site units (1 BR) in the Greater New Haven area. The Safe Haven units are handicap accessible and offer 24-hour security in the historic Ninth Square district of New Haven. Eligibility for this component includes chronically homeless individuals diagnosed with either serious mental illness, and/or chronic substance abuse, and/or HIV/AIDS. Participants may also have a physical disability or other medical conditions.

The objectives of this project are consistent with the identified problem of a lack of permanent supportive housing for homeless individuals. Columbus House, Inc. provides case management services to the scattered site residents. Additionally, participants are able to receive additional support services from a wide array of community agencies. These services may include, but are not limited to: Assessment of Service Needs, Case Management, Housing Search & Counseling, Education Services, Employment Assistance & Job Training, Food, Legal Services, Life Skills Training, Mental Health Services, Outpatient Health Services, Outreach Services, Substance Abuse Treatment Services, and Transportation.

To identify housing & support service needs, this project participates in the New Haven Coordinated Access Network, which prioritizes the most vulnerable individuals for housing resources using the nationally recognized Vulnerability Index Services Prioritization Assistance Tool (VI-SPDAT). Housing first principles are utilized to rapidly move individuals into housing when a unit becomes available. In collaboration with the participant, program staff discuss support needs (on site case management, maintenance with existing or new clinical services, vocation services, etc.) to maintain independent living.

The project will only serve eligible participants, those who have a disability and meet HUD's definition of chronic homelessness. CoC support is necessary to maintain these projects as full funding is obtained through the CoC Program Competition. The project also participates in HMIS, which is supported by the CoC.
