Explain the circumstances that led HUD to recapture funds from the most recently expired grant term related to this renewal project request.

The Hartford Hudson View Commons renewal project had some funds recaptured by HUD during the most recent expired grant term. The recaptured funds were due to the tenants having income and thus paying a higher tenant portion of the rent, as well as a departure from the program resulting in unexpended funds. In addition, the building had some turnover and a was had some water damage, resulting in lower utilization and underspent funds while the units were being prepared for new tenants. The Greater Hartford Coordinated Access Network process is improving, but has been slower than anticipated in finding CH people interested in this project-based option when scattered site options are available. We will continue to monitor expenditures for this grant.

3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

Hartford Hudson View Commons is a renewal grant that includes two components, the previous 1993 and 1994 Shelter Plus Care PRAR renewal grants. There is a critical community need for PSH to serve CH persons in the region. This project follows HUD Notice CPD-14-012 to prioritize serving CH persons w/the longest history of homelessness & most severe service needs in the order indicated in the notice. The Greater Hartford Coordinated Access Network (GH CAN) coordinates outreach to unsheltered and sheltered people, and determines priority based on length of homelessness and vulnerability, using a common assessment tool. Hudson View Commons provides on-site case management services and supportive housing subsidies to 12 individuals, prioritizing CH persons who are disabled due to severe mental illness, chronic substance abuse, co-occurring disorders or HIV/AIDS. Services are available in the City of Hartford, CT. Housing provided is in single-site apartments that are easily accessible by walking or public transportation to mainstream resources such as shopping, churches, hospital and clinics, and schools. Outreach is conducted by the community street outreach teams as part of GH CAN. GH CAN determines priority based on length of homelessness and vulnerability identified through the VI-SPDAT tool. The program follows the low-barrier, Housing First model. Case managers provide services in participant's homes or at the office, and provide bus tokens as needed. Participants receive supports to access mainstream resources and employment to enable them to improve life skills, to retain permanent housing, to obtain and maintain employment, and to access substance abuse treatment and mental health care as needed. Case managers help individuals to obtain and remain in permanent housing in the following ways: determine appropriate residence, receive landlord referrals, understand lease agreement; develop Assessment/Recovery Plan including measurable goals and objectives; link to other service providers; link to entitlements, legal assistance, social services, medical, dental, meal services, treatment and recovery groups, and education/training; provide guidance in activities of daily living, management of personal finances, meal preparation, housekeeping, tenancy skills, and conflict resolution. Case managers provide information for career exploration, on job openings or contacts, job seeking supports, resume development, job application assistance, on the job support and employment retention. Performance outcome goals include 92% of participants remaining in or exiting to permanent supportive housing, and 83% of participants 18 years old and older retaining or increasing income at end of program year or at exit. This project will continue to participate in the GH CAN and HMIS. This long-standing, stable project could not function to house participants without CoC funding and follows CoC priorities.
