3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

This project will continue to provide permanent supportive housing to eleven adult individuals who are (or were upon admission) chronically homeless, have a mental health disability, chemical addiction, HIV/AIDS, and/or co-occurring substance abuse and mental illness in scattered-site apartments in Middletown or Middlesex County, CT. We will only accept persons who are eligible for this program. We are currently providing support services for 39 formerly chronically homeless individuals in similar permanent supportive housing with state and federal funding. This will enable us to continue to house eleven individuals with SHP funds for a period of one year. We expect that our outcomes will reflect a 91% (10/11) retention rate in housing during this operating year. We operate a Housing First model - a model proven to be cost-effective and highly successful throughout the country. We will maintain the housing for eleven chronically homeless individuals in their own apartments and we will offer an array of support services (either directly or in collaboration with another community provider) which will include case management, mental health and substance abuse treatment, medical and dental service, employment counseling and supports, representative payee, transportation, legal counseling, housing search and moving costs, food and activities of daily living. Our case managers are well informed about mainstream resources and will ensure that all participants have health insurance and SNAP benefits, and that everyone eligible will have some form of income. We expect that 91% (10/11) of participants will maintain or increase their total income as of the end of the operating year. Our primary partners are: River Valley Services, Middlesex Hospital, and the Community Health Center for mental health services, Rushford, Inc. and the CT Valley Hospital for substance abuse treatment, and River Valley Services, Kuhn and United Labor Agency for employment services. The need for this program in Middlesex County has been well documented by the annual PIT. We also have a by-name registry for our CAN and we receive individuals for this program based on HUD and BOS guidance and policies. We are participating in HMIS and have been involved in the implementation of our community's coordinated access network (CAN) and we will continue to do so. It is very important to receive the financial support of the CoC for this project because we would not be able to sustain the housing or services without it.

Dedicated and DedicatedPLUS

A “100% Dedicated” project is a permanent supportive housing project that commits 100% of its beds to chronically homeless individuals and families, according to NOFA Section III.3.b.

- (6) receiving assistance through a Department of Veterans Affairs(VA)-funded homeless assistance program and met one of the above criteria at initial intake to the VA's homeless assistance system.
