3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

Supportive Housing for Veterans (VSS) provides permanent supportive housing subsidies and case management services to 4 families and 11 individuals, who meet the HUD definition of homelessness and chronically homeless, are disabled due to severe mental illness, chronic substance abuse, co-occurring disorders, or HIV/AIDS. Support services are available in the towns of Vernon, East Hartford, Manchester, and Glastonbury. The community needs in the towns served by the grant are a lack of decent affordable housing, and supportive services to assist homeless Veterans. The CoC support is needed as the vehicle by which housing subsidies are acquired for clients to afford permanent housing. Without the support of CoC and HUD funding affordable housing would not be able to assist with the homeless population in these towns, for this homeless population. Chrysalis Center follows the housing first model. Chrysalis Center plans for addressing identified service needs and housing through detailed assessments of each participant soon to be through the VI-SPDAT and other screening tools. Housing in these communities is identified through well-developed relationships with local landlords. Case managers work with landlord to secure appropriate housing. Housing is provided in scattered-site apartments located near public transportation, grocery shopping, churches, schools, and other community resources. Support services are provided at Chrysalis Center's main location or individuals' homes. Staff works in partnership with individuals to develop an Individual Recovery Plan. Participants choose self-identified service planning goals, including: accessing physical and mental health care; obtaining job skills training and education needed for employment; and finding employment. Case managers provide support for individuals to apply for Federal and State entitlement benefits; provide connection to employment training and employment resources, such as CT Works and other jobs training/employment or educational programs; and provide individuals linkage to substance abuse treatment, healthcare providers, mainstream community resources; and greater connectivity to natural supports; and to group and individual counseling. Chrysalis Center fully participates in coordinated access network (CAN) and HMIS.
