3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

The CREDO project at 1569 Thomaston Avenue provides 7 Units of Permanent Supportive Housing for chronically homeless persons living with a disability. The program participants are chronically homeless individuals with domestic violence issues, homeless persons with substance abuse problems, HIV/AIDS, and mental illness disabilities. We subscribe to the Housing First model. Housing First is a proven approach in which all people experiencing homelessness are believed to be housing ready and are provided with permanent housing immediately and with no preconditions, behavioral contingencies, or barriers.

The CREDO approach to providing housing begins where the program participant is and ensures that individuals are provided with housing choices and with access to voluntary supportive services that are tailored to meet the unique needs of each individual presenting for services and that will assist program participants achieve their goals. The services offered are determined through a collaborative process with the program participant and focus on the program participant's preferences and goals. Because of this, the supportive services offered by CREDO will likely change over time as the preferences and goals of the program participant change; however, program participants are not required to participate in services.

CREDO, through its Social Worker, relies on our community partners such as DMHAS, CT Rehabilitation Services, the CT Labor Department, and our local Community Health Centers to assist our residents access mainstream services. CREDO's client centered service methods ensure that the residents receive appropriate care in the environment of their choice.

CREDO recognizes that the individual program participants should move quickly into permanent housing. We also recognize that many cannot due to their high vulnerabilities and service needs, and also may have characteristics, such as substance use disorders, criminal records, or resistance to services.

We participate in the HMIS system. The project operates in a single site location, with 7 individual housing units and is designed with all utilities included since program participants often cannot secure utility service in their name. The units are clean, furnished, with free laundry room, electric and heat included, and free access to phone, fax, computer, wi-fi, and postage. CoC support is needed since the project would close without that support and the 9 current residents would be homeless again.

Dedicated and DedicatedPLUS

A "100% Dedicated" project is a permanent supportive housing project that commits 100% of its beds to chronically homeless individuals and families, according to NOFA Section III.3.b.

A "DedicatedPLUS" project is a permanent supportive housing project where 100% of the beds are dedicated to serve individuals with disabilities and families in which one adult or child has a disability, including unaccompanied homeless youth, that at a minimum, meet ONE of the following criteria according to NOFA Section III.3.d:

- (5) residing and has resided in a place not meant for human habitation, a safe haven, or emergency shelter for at least 12 months in the last three years, but has not done so on four separate occasions; or
- (6) receiving assistance through a Department of Veterans Affairs(VA)-funded homeless assistance program and met one of the above criteria at initial intake to the VA's homeless assistance system.

A renewal project where 100 percent of the beds are dedicated in their current grant as described in NOFA Section III.A.3.b. must either become DedicatedPLUS or remain 100% Dedicated.
