### 3B. Project Description

**1. Provide a description that addresses the entire scope of the proposed project.**

Housing for Health provides supportive housing and case management to three chronically homeless individuals with verified physical and substance use disabilities. More specifically our target is individuals with health challenges as evidenced by high medical costs and/or emergency room use. This program is critical to reducing chronic homelessness and reducing unnecessary medical costs. The need for such an intervention is documented in part by very high medical costs without achieving optimal health outcomes. Providing housing for these chronically homeless individuals reduces homelessness and unnecessary medical costs.

When we have openings we work closely with our local hospital to identify homeless individuals who are frequently hospitalized. We operate on a Housing First model. We are part of the New London County coordinated access network and all our participants are entered in HMIS. When opening occur in our HUD funded program we work in cooperation with other providers in our coordinated access network to identify the highest priority individuals. We assist participants to link to mainstream services including food pantries, health insurance, substance abuse treatment, mental health services, recovery supports and public benefits. We also have a small fund to provide for incidental expenses such as moving costs, utility deposits, short term assistance with transportation costs and other needs related to housing stability and health improvements.

Participants receive an efficiency or one-bedroom apartment in scatter site locations. All three apartments are in New London close to downtown and easily accessible to public transportation. New London Homeless Hospitality (NLHHC) directs participants to benefits for which they are eligible, and can serve as a representative payee for Social Security benefits, ensuring payment of bills. NLHHC also provides housing stability supports individualized to each participant's needs. Partners include the VNA, L + M Hospital, and Southeastern Mental Health Authority. Housing for Health reports data to HMIS. Housing stability and integration into public and community services are maintained by ongoing case management.

We propose to serve three chronically homeless individuals. Three participants are currently enrolled. Outcomes include lease maintenance or positive/neutral exits for at least 90% of participants, maintaining or increasing income for at least 90% of participants, reducing emergency room use and achieving linkages to primary care providers. CoC support is require to align our efforts with Zero2016, for guidance on best practices in documenting homelessness history and verifying disability, and for trainings and technical support on Housing First, tenant's rights, and other factors necessary to this program.
