3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

The program is designed to provide housing and related support to homeless clients (most of them chronic) with serious substance abuse and/or mental health problems that have impacted their abilities to get and keep appropriate housing. There are 4 Shelters in this area and one of them is a Domestic Violence Shelter. Those facilities are always full and we have numerous clients still living in places not meant for habitation. The program provides housing certificates, along with Case Management services. There are 60 housing certificates, of which 25 are reserved for families and 35 for singles. Of the 60, 47 vouchers (72 beds) are dedicated to chronically homeless. Through this program, stability is offered to previously homeless clients until recovery. CoC financial support is needed to continue these vital services. Case managers link clients with appropriate services to decrease hospitalization, emergency department visits, incarceration or placement in long term facilities. Clients learn how to obtain/maintain entitlements and vocational services. Units that are located in scattered sites, are consistently full and there is a waiting list. Referrals come from clients, shelters, hospitals, and other medical/behavioral agencies. CoC members meet regularly to network and to conduct homelessness diversion. There is a huge need of affordable housing in this region. The Coordinated Access Network (CAN) was created to assist in serving the most vulnerable clients using the VI/SPDAT tool. Using the Housing First approach, Case Managers work with clients to seek housing, to develop the skills necessary to maintain an apartment, and to engage in appropriate treatments. Treatment services offered at CMHA include outpatient mental health services and outpatient and intensive outpatient substance abuse treatment. Services are predominantly provided in the community. Case managers work with landlords, treatment providers, as well as the client and their family to achieve success. The success of this program is demonstrated through clients maintaining their housing or moving into section 8 vouchers, maintaining and increasing their benefits/entitlements or getting a job, and making meaningful steps toward recovery.
