Assist 15 chronically homeless individuals and 3 chronically homeless families, who suffer from mental illness and/or substance abuse issues, in maintaining housing by delivering services, including benefits/entitlements, ADL, outreach and referrals to any related services in accordance with the Housing First program.

Clients are placed into apartments scattered throughout East Hartford, CT and they hold their own leases. These program participants will receive case management, medical and clinical services. Intercommunity, the sponsor, is a local mental health authority in the State of Connecticut and has a physical health division. Therefore, these individuals will obtain appropriate services. Part of this grant provides funding for case managers to ensure that these individuals get services. Services will include medical management, individual clinical therapy, group therapy, intensive outpatient therapy, a social club, employment services, life skills training, transportation, assessment of housing needs and housing search.

Intercommunity coordinates closely on this project with The Connecticut Department of Mental Health and Substance Abuse Services. DMHAS handles all rental assistance payments and we provide all support services.

Residents are referred from homeless shelters and from the streets. We will assist clients in pursuit of benefits and potential employment. This project helps the community by taking homeless, non-working, mentally ill or substance abusing individuals and gets them off the streets and into a long term program to assist them to find permanent housing and hopefully employment.

At the end of the fiscal year, we expect that 91% of the individuals will still be in permanent housing and 94% of persons 18 and older will maintain or increase their income.

This project participates in the HMIS system and in the COC Coordinated Access program. COC financial support is a necessary part of our program as it provides the necessary rental assistance that allows our clients to remain in the program.



Our records indicate that a determination letter issued in June 1977 granted your organization exemption from federal income tax under section 501(c)(3) of the Internal Revenue Code. That letter is still in effect.

Based on information subsequently submitted, we classified your organization as one that is not a private foundation within the meaning of section 509(a) of the Code because it is an organization described in sections 509(a)(1) and 170(b)(1)(A)(vi).

This classification was based on the assumption that your organization's operations would continue as stated in the application. If your organization's sources of support, or its character, method of operations, or purposes have changed, please let us know so we can consider the effect of the change on the exempt status and foundation status of your organization.

Your organization is required to file Form 990, Return of Organization Exempt from Income Tax, only if its gross receipts each year are normally more than \$25,000. If a return is required, it must be filed by the 15th day of the fifth month after the end of the organization's annual accounting period. The law imposes a penalty of \$20 a day, up to a maximum of \$10,000, when a return is filed late, unless there is reasonable cause for the delay.

All exempt organizations (unless specifically excluded) are liable for taxes under the Federal Insurance Contributions Act (social security taxes) on remuneration of \$100 or more paid to each employee during a calendar year. Your organization is not liable for the tax imposed under the Federal Unemployment Tax Act (FUTA).

Organizations that are not private foundations are not subject to the excise taxes under Chapter 42 of the Code. However, these organizations are not automatically exempt from other federal excise taxes.

Donors may deduct contributions to your organization as provided in section 170 of the Code. Bequests, legacies, devises, transfers, or gifts to your organization or for its use are deductible for federal estate and gift tax purposes if they meet the applicable provisions of sections 2055, 2106, and 2522 of the Code.


Your organization is not required to file federal income tax returns unless it is subject to the tax on unrelated business income under section 511 of the Code. If your organization is subject to this tax, it must file an income tax return on the Form 990-T, Exempt Organization Business Income Tax Return. In this letter, we are not determining whether any of your organization's present or proposed activities are unrelated trade or business as defined in section 513 of the Code.
