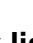

### 3B. Project Description

**1. Provide a description that addresses the entire scope of the proposed project.**

This project funds 205 scattered site units. Forty-eight of these units are designated for CH individuals and 8 of the units will serve CH families. As units turnover, 100% of the turnover will be prioritized for CH until 40% of the current non-CH beds become CH beds. Individuals & families with head of household diagnosed with serious mental illness and/or chronic substance abuse and/or HIV/AIDS are eligible. The program has partnered with four community agencies to provide case management services for at least 51 individuals & 4 families. Additionally, all participants can receive the following support services from a wide array of community agencies: Assessment of Service Needs, Case Management, Child Care, Education Services, Employment Assistance & Job Training, Food, Housing Search & Counseling Services, Legal Services, Life Skills Training, Mental Health Services, Outpatient Health Services, Outreach Services, Substance Abuse Treatment Services, & Transportation.

To identify housing & support service needs, this project participates in the New Haven Coordinated Access Network (CAN), which prioritizes the most vulnerable individuals & families for housing using the nationally recognized VI-SPDAT. Housing first principles are utilized to rapidly move individuals into housing when a certificate becomes available. Program staff in collaboration with the participant discuss support service needs to maintain independent living. The project will only serve eligible participants, those whose heads of household have a disability and meet HUD's definition of CH and/or homelessness. CoC support is necessary to maintain these projects as full funding is obtained through the CoC Program Competition and the project participates in HMIS, which is supported by the CoC.
