Thru the entire grant period we were serving 5 clients as per our grant agreement. A client started receiving benefits therefore our HAP expenditures decreased and we were unable to fill another apartment with the remaining amount and time frame.

3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

HUD Special Needs Assistance Program - Wrap Around Housing : Funds will be utilized to provide 5 rental vouchers in scattered sites throughout the Town of Killingly, utilizing the TRA (Tenant-based Rental Assistance) component to increase supportive housing. The project obtains referrals from the CAN (Coordinated Access Network) and participates in CoC outreach efforts to identify people who have been homeless the longest and have the most severe service needs. This program follows the Housing First model and offers immediate access to housing without prerequisites. The project is an essential part of the CoCs strategy to end homelessness through a combination of affordable housing and housing focused support services. We need CoC financial support to provide rental assistance to our clients.

Through the housing authorities relationship with property owners and local advertisements of available apartments we work with the client to place them in suitable housing. All 5 units will be 1 bedroom and house disabled singles who are chronically homeless according to the HUD definition. There is a great need in the Windham County to provide and maintain stable housing to the homeless. We participate in coordinated access.

The program will utilize the concept of "Wrap Around" Case Management to link clients to a full array of services that continue without interruption and ultimately eliminate barriers that once may have been the cause of the crisis or homeless circumstance. Access Community Action Agency will use qualified case management staff to coordinate the "wrap around" case management assessing their service needs and then provide on going weekly case management. The ACCESS Agency thru case management, advocacy, and referrals help participants access mainstream resources. ACCESS Agency also assist with food, utility deposits, and outreach services. Services may include access to health/dental care which is provided by Generations. Perceptions provides substance abuse treatment services. Mental health care services is provided through United Services. Ct Works and BRS (Bureau of Rehabilitate Services) provide employment training. ACCESS Agency currently uploads data to HMIS as required by the CoC through its emergency shelter grant (ESG) program.

We project all 5 of our clients to remain in permanent housing during the operating year. We also project all of the clients to maintain or increase their income as of the end of the operating year.

Dedicated and DedicatedPLUS

A “100% Dedicated” project is a permanent supportive housing project that commits 100% of its beds to chronically homeless individuals and families, according to NOFA Section III.3.b.

- (5) residing and has resided in a place not meant for human habitation, a safe haven, or emergency shelter for at least 12 months in the last three years, but has not done so on four separate occasions; or
- (6) receiving assistance through a Department of Veterans Affairs(VA)-funded homeless assistance program and met one of the above criteria at initial intake to the VA's homeless assistance system.
