3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

Prudence Crandall Center’s Rose Hill PSH (RHPSH) project provides rental subsidies and supportive services for men, women and children (10 Families) who are disabled victims of domestic violence who are also homeless. Housing is available in 10 apartments in New Britain, Connecticut, including 4 which are designated for the chronically homeless. Supportive services such as counseling, case management, advocacy, assistance with employment, tenant/landlord skill building, budgeting, and referral to mental health addiction services, life skills enhancements, as well as dental and medical services are provided by staff and partners. PCC collaborates with Community Health Center, Connecticut Mental Health Associates, and Human Resources Agency as well as a variety of other non-for-profits to provide an array of mainstream services based on each tenant’s individual needs, which are identified through case management and semi-annual assessments. As active participants in the process, PCC obtains referrals from the CAN’s Coordinated Entry System and participates in COC outreach efforts to identify people who have been homeless the longest and have the most pressing service needs. PCC’s PSH project uses a Housing First model and offers immediate housing access without prerequisites. Participants have the same tenancy rights as others in the community. Staff review the lease requirements upon entrance into the project and as needed to support lease compliance. Services are designed to assist participants in meeting lease obligations and increasing income. Staff are in frequent contact with landlords and tenants to avoid and address lease violations. Project Outcomes include: 92% of residents will remain housed as of year-end, and 90% of adults will increase their income. Current outcomes reflect 100% of participants exited to Permanent Housing, 100% had health insurance, 35% increased other income, 24% increased earned income. Prudence Crandall Center’s PSH requires support by the CoC because it addresses the community’s need for safe, affordable housing for victims of domestic violence, the chronically homeless, and specialized services for those with mental health concerns in 9 area towns. The project is an essential part of the CoC’s strategy to end homelessness through a combination of affordable housing and housing-focused support services targeted to those in the community who are victims of domestic violence experiencing homelessness the longest, and with the most intensive service needs. This project leverages mainstream resources to maximize participant income and to provide a full array of services. The project relies on CoC funding to support activities that are not funded through other sources. As a provider of domestic violence services, we do not participate in the HMIS data base. As allowed by VAWA, PCC staff use a similar but separate database called ETO. This project provides services in an integrated setting to people with disabilities.
