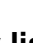

3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

Rose Hill Transitional Living Program (RHTLP) uses funds to provide apartments and services to participants who are homeless victims of domestic violence. The project provides 8 clustered apartments in New Britain, Connecticut, for up to 24 months. The project uses a low-barrier Housing First model, including no requirement for service participation or pre-requirements. Supportive services such as counseling, case management, advocacy, assistance with employment, tenant/landlord skill building, budgeting, referral to mental health/addiction services, life skills enhancements, dental and medical are provided by staff and partners. Staff provide housing advocacy to help participants locate safe, affordable Permanent Housing quickly and to achieve long-term housing stability. PCC collaborates with other non-for-profits to provide mainstream services based on each individual’s needs, identified through assessments. The project obtains referrals from the COC’s Coordinated Entry System and participates in COC outreach efforts to identify people who have been homeless the longest and have the most pressing service needs. RHTLP offers up to six months of after-care services and linkages to mainstream, community –based providers to support safety and stability post exit. Participants sign an occupancy agreement and have the same tenancy rights as others in the community. Staff review the lease requirements upon entrance, when housing is secured, and when needed to support on-going lease compliance. Services are designed to assist participants in meeting lease obligations and increasing income. Staff are in frequent contact with landlords and tenants to avoid and address lease violations. Project Outcomes include: 92% of residents exit to Permanent Housing, and 90% of adults increase their income. TH is supported by the CoC because it addresses the community’s need for safe, affordable housing for victims of domestic violence, homelessness, and specialized services for those with mental health and domestic violence concerns. The project is an essential part of the COC’s strategy to end homelessness through a combination of affordable housing and housing-focused support services targeted to those who are chronically homeless victims of domestic violence with significant needs in obtaining a lease, increasing income, and building life skills. This project leverages mainstream resources to maximize participant income and to provide a full array of services. The project relies on COC funding to support activities that are not funded through other sources. As a provider of domestic violence services, we do not participate in the HMIS data base. As allowed by VAWA, PCC staff use a similar but separate database called ETO. This project provides services in an integrated setting to people with disabilities.
