### **3B. Project Description**

**1. Provide a description that addresses the entire scope of the proposed project.**

In 2018 the PIT Count identified 594 single individuals as homeless in New Haven County. Columbus House, Inc.(CHI) as a HF provider will use is seeking CoC support to provide permanent supportive housing units located in the New Haven region for 64 single adults, all of whom will be chronically homeless. These participants will be those living with mental illness, substance abuse or other disabling condition, identified via aggressive community outreach to soup kitchens, shelters, abandoned buildings and the streets. Among those served 10 will be Veterans both men and women, who live with mental illness and substance abuse, and who may have another disabling condition. The West Haven VA will provide health care, mental health and substance abuse treatment, and employment services for all eligible Veterans. CHI participates in Coordinated Access housing exit processes using the VISPDAT a vulnerability survey determining entry into housing. Ensuring that the most in need and vulnerable will have housing priority for available units. Case Management services are voluntary, but the case manager will continue to reach out to all participants in a continued effort to engage with them. Each participant will be engaged in developing a self-directed service plan to identify housing and service needs. This plan will be revisited semi annually and per need to ensure needs are met and goals remain attainable. This will happen either in the participant’s apartment or in an agreed upon location that will allow for a private conversation. The primary focus of the staff will be to help participants maintain their housing. Services will include but are not limited to the following: food, housing search, assessment of needs, moving costs, basic life skills training, outreach, budgeting, utility expenses, transportation, recovery supports, employment, community integration and connection to natural supports. Referrals will be made for health care, mental health and substance abuse treatment, education and training opportunities, and other mainstream services.

CHI collaborates with the Department of Labor, and the Bureau of Rehabilitation Services for employment and vocational services. The Connecticut Mental Health Center and Cornell Scott Hill Health Center will partner with CHI in providing behavioral health and primary health care services. The Errera Center and VA Medical Center as partners will provide services to behavioral health care and primary care the Veterans served. Through SOAR, CHI will partner with the local SSA office in expediting the SSI/SSDI applications for the most vulnerable and disabled populations served and housed.

CHI participates in HMIS and has a trained Data Coordinator and Quality Assurance Manager responsible for data compliance, accuracy and training of all direct program staff. This project will focus of 83% of participants remaining housed and maintaining income.
