Explain the circumstances that led HUD to recapture funds from the most recently expired grant term related to this renewal project request.

As expected for this particular grant, there is always surplus dollars, because as tenants have increased their income, the housing assistance payments were lowered and the tenant portions increased. We explored a number of options to maximize utilization of funds, without success. Currently we seeking to reallocate approximately \$5000 of these surplus dollars for additional service provision.

3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

This project addresses the needs of the community by providing four permanent supportive housing units (project based) for individuals with mental health and/or addiction disorders. These units are targeted for chronically homeless individuals in a single site model which is located at 500 Boswell Avenue in Norwich, CT. The project consists of three one-bedroom units and one efficiency unit. At full capacity this project supports four single individuals. Participants must have a severe mental health and/or substance abuse disorder. All participants are offered and receive DMHAS funded PILOTS services contracted to Reliance Health (RH), Inc. that include; case management, needs assessment, mental health, crisis intervention, employment, education, budgeting, transportation, life skills, housing search, counseling, outreach and linkage to other services such as substance abuse, medical, legal, and additional housing resources such as moving, security and utility deposits. In addition to contracting PILOTS services this project closely partners and networks with numerous non-profit and state agencies to ensure the needs of participants are met. Projected program outcomes for the proposed grant year include: 100% participants will remain in permanent housing at the end of the operating year; 100% participants 18 years old and over will maintain or increase their income from any source. This project practices a Housing First Model and is closely aligned with the Coordinated Access Network process and regional goal to identify and offer immediate access to housing without prerequisites to individuals who have been homeless the longest and have the highest service needs. Outreach and/or referrals originates from the local CAN process. It is anticipated that 50% of referrals will come from persons staying in the streets or places not meant for human habitation and 50% from persons staying in emergency shelter. Housing and service needs are consumer centered and consumer driven and are identified and determined at program entry and during quarterly review and updating of service plans with each project participant. This project leverages mainstream resource to maximize client income and provide a full array of services, and relies on CoC support for continued funding, guidance, and leadership. This project also is a HMIS participant.
