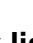

3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

This component of the Greater Hartford Rental Assistance (GHRA) program serves 14 chronically homeless households with chronic substance abuse and/or serious mental health disabilities in scattered site apartments in Manchester CT. There is a critical community need for PSH to serve CH persons in the region. This project follows HUD Notice CPD-14-012 to prioritize serving CH persons w/the longest history of homelessness & most severe service needs in order indicated per notice. The Greater Hartford Coordinated Access Network (GH CAN) is part of the statewide Coordinated Entry System (CES) that coordinates outreach to unsheltered & sheltered people, determines priority based on length of homelessness & vulnerability, using common assessment tool. Full range of behavioral health services are provided by local community behavioral health agency, Community Health Resources. Case management services staff work with participants to identify strengths, goals & issues, develop individualized service plan to meet specific goals and growth targets. Behavioral health care services address disability issues & domestic violence recovery plans. This Applicant, DHMAS, provides substance abuse & mental health care, while many non-partners are contracted with DMHAS. The program provides case management, outreach & engagement, assessment of service needs, education services, employment assistance, food, housing search & counseling services, life skills training and transportation. The project will rely on HUD funds to support activities that cannot be funded through mainstream sources; HUD CoC funds are needed to make this project possible, help end chronic homelessness in BOS & enable the community to continue work to end homelessness. Outreach is conducted by PATH staff, Housing Outreach Teams, & in all shelters. The applicant & regional providers participate in local Coordinated Access Networks (CANs), which make determinations of eligibility & ensure the VI-SPDAT is administered. Case mgmt is provided/coordinated by DMHAS agencies and contracted service providers. All non-partners work closely with the DMHAS & the local mental health authorities to ensure tenants are connected to mental health services (both state & Medicaid funded) & providers make referrals to health centers, substance use treatment, food pantries, transportation, employment, education & other services. This project has SOAR affiliation to help connect with benefits. This project follows Housing First, provides housing quickly w/o barriers such as income, sobriety, or service participation requirements. The GHRA program's experienced housing coordinators inspect apartments, confirm leases & generate proper tenant rent portion calculations. Performance goals for the program are to for over 90% of participants to retain housing for over 6 months, to exit to permanent destinations, & for 93% to maintain or increase income.
