During the first 6 months of the grant period we were serving 6 clients and the during the last 6 months we were serving 7 clients. So we were always serving the number of participants on our grant and then even added an additional client to the program since there were funds available.

3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

Putnam Wrap Around Housing Program is a tenant-based, rental assistance project that addresses the needs of HUD-defined, chronically homeless individuals with serious mental illnesses and or substance abuse. The project obtains referrals from the CoC's Coordinated Entry System and participates in the CoC outreach efforts to identify people who have been homeless the longest and have the most severe service needs. The program uses a Housing First model and offered immediate access to housing with prerequisites. The project is an essential part of the CoCs strategy to end homelessness through a combination of affordable housing and focused support services targeted to those in the community who have been homeless the longest and have the most intensive service needs. There is a great need in the Windham County to provide and maintain stable housing to the homeless. We need CoC financial support to provide rental assistance to our clients. ACCESS Agency currently uploads data to HMIS as required by the CoC through its emergency shelter grant (ESG) program.

Six eligible participants will be housed at scattered sites in Putnam, Connecticut and will be required to participate in coordinated, case management provided by The Access Agency, Inc. ACCESS Agency also assist with food, utility deposits, and outreach services. The ACCESS Agency thru case management, advocacy, and referrals help participants have access to mainstream resources. Services may include access to health/dental care which is provided by Generations. Perceptions provides substance abuse treatment services. Mental health care services is provided through United Services. CT Works and BRS(Bureau of Rehabilitate Services) provide employment training. The full intention of Putnam Wrap Around Housing Program is to get participants into stable housing and to identify the specific needs of each participant to enable self-sufficiency and promote upward mobility. Our goal is to continue assistance for the six current participants during this grant term. Without the resources provided under this grant, it is anticipated that the target population would continue on a repetitive cycle of homelessness. We project all 6 of our clients to remain in permanent housing during the operating year. We also project all of the clients to maintain or increase their income as of the end of the operating year.

Dedicated and DedicatedPLUS

A “100% Dedicated” project is a permanent supportive housing project that commits 100% of its beds to chronically homeless individuals and families, according to NOFA Section III.3.b.

A “DedicatedPLUS” project is a permanent supportive housing project where 100% of the beds are dedicated to serve individuals with disabilities and families in which one adult or child has a disability, including unaccompanied homeless youth, that at a minimum, meet ONE of the following criteria according to NOFA Section III.3.d:

- (6) receiving assistance through a Department of Veterans Affairs(VA)-funded homeless assistance program and met one of the above criteria at initial intake to the VA's homeless assistance system.
