### **3B. Project Description**

**1. Provide a description that addresses the entire scope of the proposed project.**

St. Philip House, a Housing First program, is a Rapid Re-housing program for homeless individuals living with HIV/AIDS. The St. Philip House Rapid Re-housing Program is a program designed to provide financial assistance to 10 - 12 households and support services to assist formerly homeless adults in maintaining their housing. The St. Philip House Rapid Re-housing Program households that receive assistance must live in the Central and Greater Hartford Coordinated Access Network and must be currently homeless, HIV+ and would remain homeless, but for this assistance.

The primary focus of the program is to provide our residents with safe, affordable, housing with supports. St. Philip House serves homeless individuals with HIV/AIDS who are also veterans, youth, and victims of domestic violence. Each household serves at least one adult who meets one or more of the HUD disability requirements of: living in places not intended for human habitation, victims of domestic violence, and/or staying in emergency shelters, living in transitional housing for homeless individuals, or a person who has been in one of these locations but who has been in jail for less than 30 days and is still considered homeless. In addition to housing, our residents receive a variety of services from their case managers. We provide energy assistance, food assistance, tuition assistance, auto repair assistance, legal assistance, transportation, substance abuse counseling, after-school programs assistance for the children, assistance with moving costs, clothing assistance for the children and much more funded through HUD. HUD-funded Case Managers will assist clients in setting appointments for necessary services. St Philip House works closely with area mental health treatment and substance abuse treatment centers and with local hospitals for primary care services. During the proposed grant year, 60% of our participants will graduate and pay 100% of their rent in 6 months, 40% of our participants will graduate in 9 months and pay 100% of their rent, 90% of participants will maintain or increase income, 100% of individuals with HIV will remain connected to medical providers and 85% will remain in permanent housing for 12 months after exit from Rapid Re-housing services.

St. Philip House participates in the Coordinated Access (CAN) and HMIS systems and submits monthly reports to the appropriate agencies.
