### 3B. Project Description

**1. Provide a description that addresses the entire scope of the proposed project.**

The Department of Mental Health and Addiction Services is the applicant of this project. The project will be supervised and administered locally by the Western Connecticut Mental Health Network Waterbury office. This project will serve 20 chronically homeless individuals who have mental health and/or substance abuse and/or HIV/AIDS disabilities.

This project is supported by the CoC because it addresses the community’s need for CH designated beds and specialized services for people with serious mental illness. The project is an essential part of the CoCs strategy to end chronic homelessness through a combination of affordable housing and housing focused support services targeted to those in the community who have been homeless the longest and have the most intensive service needs. The project leverages mainstream resources to maximize client income and provide a full array of services. This Supportive Housing Program will continue to utilize Tenant Based Rental Assistance and will house persons in scattered site housing units. The units are primarily 1BR units.

The project coordinator collaborates with a variety of service providers to ensure that persons are connected with all appropriate services and financial benefits. Services include mental health, substance abuse, HIV/AIDS, services for veterans, employment/education services and life skills. The case management services are provided by the Western Connecticut Mental Health network. The

WCMHN works with the local mental health, substance abuse, employment and homeless provider agencies ie; Waterbury Hospital, Human Resource Development, Midwestern Council on Alcoholism, Connecticut Renaissance, WellMore, Center for Human Development to ensure that all participants are connected with needed services. The case manager will assist individuals in increasing their income by assisting households in applying for all eligible state and federal benefits including SAGA cash, SSI, SSDI, Medicaid, Medicare and SNAP. Case managers will assist households in connecting with local labor department and Human Resource Development for job training and job search skills. Ninety percent of the participants will have remained in permanent housing at the end of the operating year and will have maintained or increased their income from all sources.

This project participates in the Litchfield County/Waterbury Coordinated Entry Network. The project obtains referrals from the CoC’s Coordinated Entry System and participates in CoC outreach efforts to identify people who have been homeless the longest and have the most severe service needs.

The project uses a Housing First model and offers immediate access to housing without prerequisites.

Participants have leases in their own name and the same tenancy rights as others in the community.

The project uploads data to HMIS as required by the CoC.
