We will continue to monitor expenditures for this grant and will continue to house additional people as funding allows

3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

This renewal project will continue to serve 31 homeless individuals and 8 homeless families with substance abuse and/or mental health disabilities. Of this total, 24 individuals are chronically homeless. The Department of Mental Health and Addiction Services will continue to be the applicant. Project will be administered locally by the Western Connecticut Mental Health Network in Danbury, CT. This project is supported by the CoC because it addresses the community’s need for CH designated beds and specialized services for people with serious mental illness. The project is an essential part of the CoCs strategy to end chronic homelessness through a combination of affordable housing and housing focused support services targeted to those in the community who have been homeless the longest and have the most intensive service needs. The project leverages mainstream resources to maximize client income and provide a full array of services.

This project will continue to utilize tenant based rental assistance and will house persons in scattered site housing units. The units will be primarily 1BR, 2BR and 3BR units. The tenants will pay 30% of their income for rent. The WCMHN works with a variety of service providers to ensure that persons are connected with all appropriate services and financial benefits. Services include mental health, substance abuse, services for veterans, education and employment/vocational services. The case management services will be provided by a variety of services agencies including the Western Connecticut Mental Health Network, Catholic Charities CSP, Homeless Outreach and Aids Project Greater Danbury, Danbury Hospital and other mental health, substance abuse and employment agencies to ensure that all participants are connected with needed services. The participants will be assisted in increasing their income by having their service provider assist them in applying for all eligible state and federal benefits including SAGA cash, SSI, SSDI, Medicaid, Medicare and SNAP. Case managers will assist individuals in connecting with local labor department and Ability Beyond to get job training and job search skills. Ninety-One percent of the participants will have remained in permanent housing at the end of the operating year; 90% of the participants age 18 or older will have maintained or increased their income from all sources.

This project participates in the Fairfield County/Danbury Coordinated Entry Network. The project obtains referrals from the CoC’s Coordinated Entry System and participates in CoC outreach efforts to identify people who have been homeless the longest and have the most severe service needs. The project uses a Housing First model and offers immediate access to housing without prerequisites.

Participants have leases in their own name and the same tenancy rights as others in the community.

The project uploads data to HMIS as required by the CoC.
