### 3B. Project Description

**1. Provide a description that addresses the entire scope of the proposed project.**

This permanent supportive housing renewal project will continue to serve homeless individuals with mental health/substance abuse disabilities. The Housing Authority, City of Waterbury is the primary applicant for this project, with Western Connecticut Mental Health Network's Waterbury office providing case management services as the project sponsor. The grant provides housing for 10 chronically homeless individuals. Beds are 100% dedicated to chronic homeless population. The units are primarily 0BR. This project is supported by the CoC because it addresses the community's need for CH designated beds and specialized services for people with serious mental illness.

This project will continue to utilize project based rental assistance and will house persons in single site housing units.

The program provides services in an integrated setting to people with disabilities.

WCMHN collaborates with a variety of service providers to ensure that persons are connected with all appropriate services and financial benefits.

Services include mental health, substance abuse, HIV/AIDS, services for veterans, employment/education services and life skills.

The participants will be assisted in increasing their income in applying for all eligible state and federal

benefits including SAGA cash, SSI, SSDI, Medicaid, Medicare and SNAP.

Participants are assisted in connecting with local labor department to get job training and job search skills. Ninety percent of the participants will have remained in permanent housing at the end of the operating year and will have maintained or increased their income from all sources.

This project participates in the Litchfield County/Waterbury Coordinated Entry Network.

The project obtains referrals from the CoC's Coordinated Entry System and participates in CoC outreach efforts to identify people who have been homeless the longest and have the most severe service needs.

The project uses a Housing First model and offers immediate access to housing without prerequisites.

Participants have leases in their own name and the same tenancy rights as others in the community.

The project uploads data to HMIS as required by the CoC.
