# 1. Provide a description that addresses the entire scope of the proposed project.

During the 2018 Middlesex PIT 15 adults in families including 18 children were identified homeless. Middlesex Rapid Re-housing is seeking CoC support to provide a Housing First modeled Rapid Re-housing program (RRH). This program is seeking financial assistance to provide short-term and/or mediumterm rental assistance for families that are homeless. This program will serve (6) families at ant point in time and (8-10) families annually as we expect turnovers, the goal is to serve at least (28) people, up to (16) adults and (12) children, through this program, depending on the level of support and length of time that support is offered. Identified via aggressive community outreach to soup kitchens, shelters, abandoned buildings and the streets. CHI participates in Coordinated Access housing exit processes using the VISPDAT a vulnerability survey determining entry into housing. Ensuring that the most in need and vulnerable will have housing priority for available units and RRH. The program will serve both chronically homeless and non-chronic with support for newly homeless in an effort to keep them from long stays in the shelter system. Families find their own apartments, with financial support from this program. Once the financial assistance ends, families will be able to stay in the apartment on their own, or with long term subsidies from other sources. Services will continue throughout the term of RRH assistance and for 3 months post assistance to ensure that the family is able to maintain their housing.

Staff will assist families with basic case management services, which will include helping families to secure permanent housing. RRH staff will work with existing providers in the Middletown area to ensure that families who need long term subsidies are on existing wait lists. We will refer family members to employment services in Middlesex County such as KUHN. Referrals will also be made to mainstream benefits such as food stamps, health care, and mental health/substance abuse treatment as needed. Children will be enrolled in school per McKinney Vento. This HUD funded RRH will work in coordination with the existing program, and will come under the supervision of the current program manager. Services will include but are not limited to the following: food, housing search, assessment of needs, basic life skills training, budgeting, utility expenses, transportation, recovery supports, employment, community integration and connection to natural supports. Referrals will be made for health care, mental health and substance abuse treatment, education and training opportunities, and other mainstream services. Among those rapidly rehoused 83% will maintain or increase income and 93% will remain housed or exit into permanent housing.

Columbus House participates in HMIS and has a trained Data Coordinator and Quality Assurance Manager responsible for data compliance, accuracy and training of all direct program staff.
