### 3B. Project Description

**1. Provide a description that addresses the entire scope of the proposed project.**

Funds for this project will be used for rapid rehousing services for families. The fiduciary is the CT Department of Mental Health and Addiction Services (DMHAS) and New Reach will be the subcontractor. DMHAS will be administering this grant including reporting and New Reach, as the subcontractor, will be managing the units and case management using a Housing First model. In order to help meet the need for these families, New Reach will fund a .5FTE part-time Rapid Re-Housing (RRH) case manager for the Greater New Haven Coordinated Access region for this project. New Reach will serve clients exiting shelters and those living on the streets or other place not meant for human habitation and who come through the local Coordinated Access Network (CAN). New Reach has a solid infrastructure in place for RRH services. With these funds, New Reach anticipates being able to provide rental assistance and support services to 21 households over the period of the grant year. The target population is families with dependent children. Housing will be scattered site in the Greater New Haven area. All program data will be entered through HMIS. New Reach is actively participating in the local CAN system for both individuals and families.

There is a critical need for rapid rehousing services in the Greater New Haven region. As of August 2018, there were 320 families on Greater New Haven family registry. Of these 320 families, 200 (63%) scored in the Rapid Rehousing range of the VI-SPDAT. Our current regional rapid rehousing program (state funded) is consistently at capacity and often times has a waiting list.

New Reach will provide three primary services. First, families will receive case management services. Second, families will be assisted with their housing search through our agency Housing Specialist, whose role it is to locate appropriate and affordable housing for our rapid rehousing clients. The Housing Specialist has already formed strong relationships with landlords in the region. Third, the case manager will assess clients' needs. Clients and staff will co-create action plans that will identify both the strengths and needs of the client to guide the work during the program. New Reach has strong working relationships with other service providers and will make referrals on an as needed basis. These needs may include; childcare, education, employment, food, legal, mental or medical health, and substance abuse. It is anticipated that 86% of participating clients will remain in permanent housing at the end of the year. Further, we expect that 70% of family head of households will increase their income (earned and benefits) over the course of a year.


