3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

Through Project Teach 2018-2019, 20 scattered-site apartments, will house chronically homeless and disabled households, age 18 and over including youth 18-24 using a low-barrier housing first model with no employment requirement for housing and no disqualifications for substance use or non-agreement to participate in treatment. The Continuum prioritizes individuals with high VI-SPDAT scores for referral to this permanent supportive housing programs as these are the people who are most in need of longer term services and most at-risk of premature death if they are not housed. Clients will be recruited through the Greater Hartford Coordinated Access Network, which has collaborative outreach and provides a shared prioritized way of identifying those most vulnerable clients best suited for PSH. Given the population of chronically homeless persons in this region, all beds will be dedicated to chronically homeless single adults, almost all of whom will be over age 25.

This program could not function or continue housing participants without CoC funding. Although support services are not mandatory, they can make an enormous difference in the lives of these clients. CRT has a very good track record in providing and linking individuals with a wide range of resources. Our case managers work closely with clients using Motivational Interviewing techniques. A high percentage of Project Teach clients have co-occurring disorders and our behavioral health services have been instrumental in helping clients to decrease substance use. Clients also benefit from financial literacy, improved access to medical care (as many have physical health problems), vocational training, education, access to transportation and other programs/services. CRT coordinates with partners in its CoC and with external agencies to offer services to clients that help them to maintain their housing and upgrade their skills.

Apartments are one-bedroom tenant rentals. Accessibility to resources in the community is a key factor as clients choose scattered-site apartment locations. As with all of CRT's HUD projects, Project Teach participates fully in HMIS. Outcome measures include: 90% of participants will retain or exit to permanent housing at the end of the operation year and 88% of participants will maintain or increase their total income, with the caveat that younger participants (age 18-24) are often in training or educational programs that decrease their time for employment. This, in turn, can affect their immediate income, possibly bringing down the overall percentage in this category.
